**PROVINCIAL RESOLUTION NO. 450-2025**

**AUTHORIZING THE HONORABLE GOVERNOR, RAMON V. GUICO III, TO ENTER INTO AND SIGN A CONTRACT AGREEMENT WITH GMA NETWORK, INC. RELATIVE TO THE PROVISION OF TELEVISION/RADIO BROADCASTING FACILITIES FOR THE KAPUSO FIESTA EVENT ON APRIL 10-12, 2025**

**WHEREAS**, the Provincial Government of Pangasinan will be celebrating the 2025 Pista'y Dayat, also known as the Sea Festival, which is a cultural, environmental, and thanksgiving festival held in the Province of Pangasinan every first of May;

**WHEREAS**, GMA Network, Inc. was incorporated in June 14, 1950 as a free-to-air broadcasting company principally engaged in television and radio broadcasting, the production of programs for domestic and international audiences, and other related businesses;

**WHEREAS**, for this year's Pista'y Dayat celebration, GMA Network, Inc. shall be the strategic partner of the Provincial Government of Pangasinan in the conduct of the Kapuso Fiesta Event which will feature Kapuso artists on April 10-12, 2025;

**WHEREAS**, this partnership between the Province of Pangasinan and GMA Network, Inc. would eventually result to the fruitful and joyful celebration of the Pista'y Dayat 2025;

**WHEREAS**, local government units are empowered under Section 22 (a) (5) (c) and Section 465 (b) (vi) of RA 7160 to enter into contracts, but such power may be exercised with prior authorization emanating from the Sangguniang Panlalawigan through a resolution/ordinance;

**NOW THEREFORE**, on motion of SP Member Marinor B. de Guzman, duly seconded, it was –


