PROVINCIAL RESOLUTION NO. 452-2025

AUTHORIZING THE PROVINCIAL GOVERNOR, RAMON V. GUICO III, TO ENTER INTO AND SIGN A MEMORANDUM OF AGREEMENT BETWEEN AND AMONG THE PROVINCIAL GOVERNMENT OF PANGASINAN, UNIVERSITY OF THE PHILLIPPINES, LYCEUM NORTHWESTERN UNIVERSITY, PANGASINAN POLYTECHNIC COLLEGE, PANGASINAN STATE UNIVERSITY, PANPACIFIC UNIVERSITY, PHINMA UNIVERSITY OF PANGASINAN, UNIVERSIDAD DE DAGUPAN, UNIVERSITY OF EASTERN PANGASINAN, UNIVERSITY OF LUZON, URDANETA CITY UNIVERSITY, VIRGEN MILAGROSA UNIVERSITY FOUNDATION, AND WCC AERONAUTICAL AND TECHNOLOGICAL COLLEGE TO FORMALIZE THE RENEWAL AND EXPANSION OF THE CENTER FOR PANGASINAN STUDIES (CPS) CONSORTIUM

WHEREAS, in order to further strengthen, promote and develop the history and culture of Pangasinan so as to maintain the distinctive place of the Province in the society, Provincial Ordinance No. 199-2016 of the Sangguniang Panlalawigan of Pangasinan was enacted, establishing the Center for Pangasinan Studies (CPS), the research and development arm of the Province of Pangasinan;

WHEREAS, the CPS was institutionalized in 2016 through the collaboration among the Province of Pangasinan, the University of the Philippines, and several Pangasinan higher education institutions (HEIs), namely, University of Luzon, PHINMA University of Pangasinan, Lyceum Northwestern, Virgen Milagrosa University Foundation, and Universidad de Dagupan;

WHEREAS, in 2022, the CPS consortium of Pangasinan HEIs was expanded with the inclusion of two institutions, namely, Pangasinan State University and the University of Eastern Pangasinan;

WHEREAS, four more Pangasinan HEIs, namely, Pangasinan Polytechnic College, Urdaneta City University, Panpacific University and WCC Aeronautical and Technological College, Inc., all of whom are likewise equipped with resources and capabilities for research and development, were recently added to the membership of the CPS consortium;

WHEREAS, with the expansion of the CPS consortium from its initial five HEI members in 2016 to the current eleven HEI members, there is a need to renew the memorandum of agreement;

WHEREAS, the Province of Pangasinan recognizes the commitment, integrity, discretion and standing in respect to the areas of specialization of every Pangasinan HEI consortium member, who will work together towards the preservation, promotion and propagation of the historical and cultural heritage of the Province;

WHEREAS, for the above purpose, a Memorandum of Agreement shall be entered into and signed between and among the Provincial Government of Pangasinan, represented by Honorable Governor Ramon V. Guico III; University of the Philippines, represented by its President, Atty. Angelo A. Jimenez; and the Pangasinan HEIs represented by their respective Presidents, namely: Lyceum Northwestern University, represented by Luz T. Duque; Pangasinan Polytechnic College, represented by Raymundo D. Rovillos, Ph. D; Pangasinan State University, represented by Elbert M. Galas, DIT; Panpacific University, represented by Rhonda T. Padilla, Ph. D; PHINMA University of Pangasinan, represented by Christopher A. Tan; Universidad de Dagupan, represented by Feliza Arzadon-Sua, Ed. D; University of Eastern Pangasinan, represented by Evelyn A. Tomboc, DBA; University of Luzon, represented by Luis M. Samson, Jr., Ed. D; Urdaneta City University, represented by Amihan April C. Mella-Alcazar, Ph. D; Virgen Milagrosa University Foundation, represented by Ma. Lilia P. Juan, M.D., FPCHA; and, WCC Aeronautical and Technological College, represented by Raymond Patrick V. Guico, DBA;

WHEREFORE, on motion of Vice Governor Mark Ronald DG. Lambino, duly seconded, it was –

RESOLVED, by the Sangguniang Panlalawigan in session assembled, to authorize, as he is hereby authorized, the Provincial Governor, Ramon V. Guico III, to enter into and sign a Memorandum Of Agreement between and among the Provincial Government of Pangasinan, University of the Philippines, Lyceum Northwestern University, Pangasinan Polytechnic College, Pangasinan State University, Panpacific University, PHINMA University of Pangasinan, Universidad de Dagupan, University of Eastern Pangasinan, University of Luzon, Urdaneta City University, Virgen Milagrosa University Foundation, and WCC Aeronautical and Technological College to formalize the renewal and expansion of the Center for Pangasinan Studies (CPS) Consortium;


