**PROVINCIAL RESOLUTION NO. 457-2025**

**AUTHORIZING THE PROVINCIAL GOVERNOR, RAMON V. GUICO III, TO ENTER INTO AND SIGN A MEMORANDUM OF AGREEMENT BETWEEN AND AMONG THE MELCO RESORTS (PHILIPPINES) FOUNDATION CORPORATION AND THE MELCO RESORTS LEISURE CORPORATION AND ACCEPT THE 9,500 SCHOOL KITS WORTH THIRTY MILLION PESOS (P30,000,000.00) TO BE DISTRIBUTED TO STUDENTS WITHIN THE PROVINCE OF PANGASINAN**

**WHEREAS**, the Melco Resorts (Philippines) Foundation Corporation and the Melco Resorts Leisure Corporation are duly organized and existing corporations in the country which support programs and projects of the national and local government;

**WHEREAS**, the Melco Leisure, a licensee of the Philippine Amusement and Gaming Corporation (PAGCOR), has set aside funds pertaining to the restoration of cultural heritage, education, environment and health projects;

**WHEREAS**, the Melco Resorts (Philippines) Foundation Corporation and the Melco Resorts Leisure Corporation have manifested their desire to provide the needed educational assistance of the Provincial Government of Pangasinan through the donation of 9,500 school kits worth P30,000,000.00, subject to the terms and conditions stipulated in the Memorandum of Agreement;

**WHEREAS**, it is to the best interest of the provincial government to sign the Deed of Donation and accept the school kits from Melco Resorts (Philippines) Foundation Corporation and the Melco Resorts Leisure Corporation to augment the necessary tools for learning and development needs of the students within the Province of Pangasinan, thereby promoting equity and equal access to education;

Guico III, Melco Resorts (Philippines) Foundation Corporation, represented by its President and Chairman of the Board, Mr. Clarence Yuk Man Chung, and its Vice President, Mr. Armin Antonio B. Raquel Santos, and the Melco Resorts Leisure Corporation, represented by its Property President, Mr. Geoffry Andres;

**NOW, THEREFORE**, in view of the foregoing, on motion of SP Member Napoleon C. Fontelera, Jr., duly seconded, it was –

**RESOLVED**, by the Sangguniang Panlalawigan in session assembled to authorize, as he is hereby authorized, the Honorable Governor, Ramon V. Guico III, to enter into and sign a Memorandum of Agreement between and among the Melco Resorts (Philippines) Foundation Corporation and the Melco Resorts Leisure Corporation and accept the 9,500 school kits worth Thirty Million Pesos (P30,000,000.00) to be distributed to students within the Province of Pangasinan;
