**PROVINCIAL RESOLUTION NO. 459-2025**

**REQUESTING THE SOCIAL SECURITY SYSTEM (SSS) FOR THE  
CONVERSION OF THE SSS SERVICE OFFICE IN LINGAYEN  
INTO A FULL-SERVICE OFFICE/BRANCH**

**WHEREAS**, the Social Security System (SSS) is considered as one of the frontline services of the national government which plays a crucial role in providing social security protection to workers in the private sector, wage earners as well as self-employed persons;

**WHEREAS**, the Sangguniang Panlalawigan of Pangasinan enacted Provincial Resolution No. 377-2025, dated March 17, 2025, authorizing the Provincial Governor, Ramon V. Guico III, to enter into and sign a Memorandum of Agreement with the Social Security System (SSS) for the use of an office space owned by the Province of Pangasinan located at the ground floor of the Pangasinan Employment Services Office (PESO) Building, Capitol Compound, Lingayen, Pangasinan;

**WHEREAS**, the SSS Service Office – Lingayen located at the aforesaid building currently provides limited services to its members and pensioners;

**WHEREAS**, in order to further improve the welfare and provide the needed social protection benefits and services to the public, the Provincial Government of Pangasinan respectfully requests the Social Security System to consider the conversion of the SSS Service Office in Lingayen into a full-service office/branch;

**WHEREAS**, the conversion of the SSS Service Office in Lingayen to a full-service office would greatly enhance the accessibility and convenience for SSS members and beneficiaries not only for the area, but also from other parts of the province;

**WHEREAS**, a full-service office would enable the SSS to provide a wider range of services, including but not limited to, registration, benefit claims, and inquiries, thus, improving the overall efficiency and effectiveness of the SSS operations in the Province of Pangasinan;

**NOW, THEREFORE**, on motion of SP Member Jerry Agerico B. Rosario, duly seconded, it was -


