PROVINCIAL RESOLUTION NO. 461-2025

AUTHORIZING THE PROVINCIAL GOVERNOR, RAMON V. GUICO III, TO ENTER INTO AND SIGN A MEMORANDUM OF AGREEMENT WITH THE ILOCOS TRAINING AND REGIONAL MEDICAL CENTER FOR THE IMPLEMENTATION OF THE ITRMC NURSING-LEARNING AND DEVELOPMENT (IN-LEAD) NETWORK IN THE PROVINCE OF PANGASINAN

WHEREAS, the ITRMC Nursing-Learning and Development (IN-LEAD) Network is a training program established by the Ilocos Training and Regional Medical Center aimed at capacitating health partners in Region I through accredited and relevant learning and development programs and trainings;

WHEREAS, the ITRMC Nursing-Learning and Development (IN-LEAD) Network is composed of various nursing skills training and competency enhancement programs such as face and online In-Service Lectures, Virtual Home Healthcare, and the Best Sharing Summit (Ibur-ay Iti Sillag);

WHEREAS, the ITRMC Nursing-Learning and Development (IN-LEAD) Network, that is being offered by ITRMC to the Province of Pangasinan, aims to equip and enhance the knowledge and clinical skills of the nurses in the Province;

WHEREAS, the Provincial Government of Pangasinan, through the Lingayen District Hospital, in partnership with the Ilocos Training and Regional Medical Center, will join efforts in implementing the said notable program;

WHEREAS, the duties and responsibilities of each party in the implementation of the program are already defined in the MOA;

WHEREAS, the subject Memorandum of Agreement between the Province of Pangasinan and the Ilocos Training and Regional Medical Center shall have a term of two (2) years to take effect from March 2025 to March 2027;

WHEREAS, local government units are empowered under Section 22 (a) (5) (c) and Section 465 (vi) of RA 7160 to enter into contracts, but such power may be exercised with prior authorization emanating from the Sangguniang Panlalawigan through a resolution/ordinance;


WHEREAS, for the above purpose, a Memorandum of Agreement shall be entered into and signed between the Province of Pangasinan, represented by Governor Ramon V. Guico III, and the Ilocos Training and Regional Medical Center, represented by Dr. Eduardo M. Badua III, Medical Center Chief II;

NOW, THEREFORE, on motion of SP Member Shiela Marie F. Baniqued, duly seconded, it was –


