APPROVING RESOLUTION NO. 2024-235 OF THE SANGGUNIANG BAYAN OF SUAL, PANGASINAN, ENTITLED "APPROVING THE SUPPLEMENTAL INVESTMENT PROGRAM (SIP) NO. 6, C.Y. 2024 OF SUAL, PANGASINAN AMOUNTING TO SIXTEEN MILLION NINE HUNDRED FORTY THOUSAND FIFTY-FIVE & 79/100 (P16,940,055.79)

WHEREAS, the Sangguniang Bayan of Sual, Pangasinan submitted its Resolution No. 2024-235 to the Sangguniang Panlalawigan for review and evaluation pursuant to Section 56 of the Republic Act No. 7160, otherwise known as the Local Government Code of 1991;

WHEREAS, the Committee on Laws and Ordinances of the Sangguniang Panlalawigan with the technical assistance of the Provincial Planning and Development Officer have conducted initial review and study on said Resolution with the following findings:

- 1. Subject resolution is in consonance to Sections 106, 109 and 114 of the Local Government Code (LGC) of 1991. The Local Development Council of Sual, Pangasinan had identified items in their Supplemental Investment Program (SIP) No. 6 for CY 2024. This was endorsed to the Sangguniang Bayan for approval on December 12, 2024 by the Municipal Development Council through Resolution No. 9, Series of 2024;
- 2. The SIP No. 6 of the municipality covers fund augmentation for Personal Services (granting of Collective Negotiation Agreement incentive to qualified officials/employees and other personnel benefits), Maintenance and Other Operating Expenses, and Capital Outlay of some municipal government offices; and

3. Funding support for the implementation of the same in the amount of PhP16,940,055.79 is embodied in their proposed Supplemental Budget No. 06 CY 2024 which was enacted by their Sangguniang Bayan through Appropriation Ordinance No. 07, on December 23, 2024.

WHEREAS, the Sangguniang Panlalawigan, after final evaluation, finds the subject resolution in order, however, compliance with all the existing laws, rules and regulations shall be the responsibility of the Municipal Government of Sual, Pangasinan;

WHEREFORE, in view of the foregoing, on motion of SP Members Napoleon C. Fontelera, Jr. and Apolonia DG. Bacay and co-sponsored by SP Members Carolyn D. Sison, Joyce D. Fernandez and Raul R. Sabangan, duly seconded, it was—

RESOLVED, by the Sangguniang Panlalawigan in session assembled, to approve SB Resolution No. 2024-235 of the Sangguniang Bayan of Sual, Pangasinan, entitled "Approving the Supplemental Investment Program (SIP) No. 6, C.Y. 2024 of Sual, Pangasinan amounting to Sixteen Million Nine Hundred Forty Thousand Fifty-five & 79/100 (P16,940,055.79)";
