DECLARING ORDINANCE NO. 232, S-2024 OF THE SANGGUNIAN BAYAN OF BASISTA, PANGASINAN, ENTITLED “AN ORDINANCE AMENDING MUNICIPAL ORDINANCE NO. 50-A, SERIES OF 2011, ENTITLED “AN ORDINANCE ADOPTING A COMPREHENSIVE AND MANDATORY TRAFFIC CODE IN THE MUNICIPALITY OF BASISTA, PANGASINAN AND PRESCRIBING PENALTIES FOR VIOLATION THEREOF” AS WITHIN THE CONFERRED POWERS OF THE SANGGUNIAN BAYAN TO ENACT

WHEREAS, the Sangguniang Bayan of Basista, Pangasinan submitted its Ordinance No. 232, S-2024 to the Sangguniang Panlalawigan for review and evaluation pursuant to Section 56 of Republic Act No. 7160, otherwise known as the Local Government Code of 1991;

WHEREAS, the Committee on Laws and Ordinances of the Sangguniang Panlalawigan with the technical assistance of the Provincial Legal Officer have conducted initial review and study on said ordinance and found out that the same was enacted in accordance with Sections 16 and 447 (a) (1) (iii) (3) (vi) (5) of Republic Act No. 7160;

WHEREAS, the subject ordinance shall take effect after compliance with the requirement of publication pursuant to Section 511 (a) of R.A. No. 7160;


