## **RESOLUTION NO. 466-2025**

DECLARING ORDINANCE NO. 5-S-2024 OF THE SANGGUNIANG BAYAN OF SAN FABIAN, PANGASINAN, AN ORDINANCE ESTABLISHING A MARICULTURE PARK AND GRANTING FISHERY PRIVILEGES FOR OPERATING FISH CAGES IN THE MUNICIPAL COASTAL WATERS OF SAN FABIAN, PANGASINAN" AS WITHIN THE CONFERRED POWERS OF THE SANGGUNIAN TO ENACT

WHEREAS, the Sangguniang Bayan of San Fabian, Pangasinan submitted its Ordinance No. 5-S-2024 to the Sangguniang Panlalawigan for review and evaluation pursuant to Section 56 of Republic Act No. 7160, otherwise known as the Local Government Code of 1991;

WHEREAS, the Committee on Laws and Ordinances of the Sangguniang Panlalawigan with the technical assistance of the Provincial Legal Officer have conducted initial review and study on said ordinance and found out that the same was enacted in accordance with Sections 17 (b) (i) and 447 (a) (iii) of Republic Act No. 7160; Section 16 of Republic Act No. 8550, also known as "An Act Providing for the Development, Management and Conservation of the Fisheries and Aquatic Resources, Integrating All Laws Pertinent Thereto, and for Other Purposes";

**WHEREAS,** the subject ordinance shall take effect after compliance with the requirements of posting and publication pursuant to Sections 59 and 511 (a) of R.A. No. 7160;
