APPROVING MUNICIPAL RESOLUTION NO. 2024-240 OF THE SANGGUNIANG BAYAN OF ALCALA, PANGASINAN, ENTITLED "APPROVING THE SUPPLEMENTAL ANNUAL INVESTMENT PROGRAM NO. 04 FOR CALENDAR YEAR 2024 OF THE MUNICIPALITY OF ALCALA, PANGASINAN

WHEREAS, the Sangguniang Bayan of Alcala, Pangasinan submitted its Resolution No. 2024-240 to the Sangguniang Panlalawigan for review and evaluation pursuant to Section 56 of the Republic Act No. 7160, otherwise known as the Local Government Code of 1991;

WHEREAS, the Committee on Laws and Ordinances of the Sangguniang Panlalawigan with the technical assistance of the Provincial Planning and Development Officer have conducted initial review and study on said Resolution with the following findings:

- Subject resolution is in consonance to Sections 106, 109 and 114 of the Local Government Code (LGC) of 1991. The Municipal Development Council of Alcala, Pangasinan has identified items in their Supplemental Annual Investment Program No. 04. This was endorsed to the Sangguniang Bayan for approval on December 19, 2024 by the Municipal Development Council-Executive Committee through Resolution No. 2024-06;
- 2. The SAIP covers fund augmentation for Personal Services and MOOE of various offices of the municipality and implementation of disaster risk reduction programs and projects of the municipality; and

> Funding support for the full implementation of the same in the amount of Php5,249,169.67 is embodied in their proposed Supplemental Budget No. 4 for CY 2024 which was approved and enacted by their Sangguniang Bayan through Appropriation Ordinance No. 2024-05 on December 20, 2024 and approved by the Municipal Mayor on December 27, 2024.

WHEREAS, the Sangguniang Panlalawigan, after final evaluation, finds the subject resolution in order, however, compliance with all the existing laws, rules and regulations shall be the responsibility of the Municipal Government of Alcala, Pangasinan;
