#### **RESOLUTION NO. 469-2025**

APPROVING RESOLUTION NO. 2024-250 OF THE SANGGUNIANG BAYAN OF BINALONAN, PANGASINAN, ENTITLED "ADOPTING THE ANNUAL INVESTMENT PLAN OF THE MUNICIPALITY OF BINALONAN FOR CALENDAR YEAR 2025

WHEREAS, the Sangguniang Bayan of Binalonan, Pangasinan submitted its Resolution No. 2024-250 to the Sangguniang Panlalawigan for review and evaluation pursuant to Section 56 of the Republic Act No. 7160, otherwise known as the Local Government Code of 1991;

WHEREAS, the Committee on Laws and Ordinances of the Sangguniang Panlalawigan with the technical assistance of the Provincial Planning and Development Officer have conducted initial review and study on said Resolution with the following findings:

- 1. In pursuance to Sections 106, 109, and 114 of the Local Government Code of 1991, the Local Development Council of Binalonan, Pangasinan has formulated the municipality's Annual Investment Program for Calendar Year 2025, which was endorsed to the Sangguniang Bayan for approval through MDC Resolution No. 03-2024 dated June 27, 2024;
- 2. The AIP of the municipality is in accordance with the Budget Operations Manual (BOM) for LGUs, 2023 Edition and in pursuance to DILG-NEDA-DBM-DOF Joint Memorandum Circular No. 1 series of 2007 dated March 8, 2007 DBM-CCC-DILG JMC No. 2014-01 dated August 7, 2014, as amended by DBM-CCC-DILG JMC No.2015-01 dated July 23, 2015 as to format and content. was formulated following the prescribed AIP Summary Form categorized into general public, social, economic, and other services. It likewise covers: (a) all the regular budgetary items for the operations of the different municipal offices broken down into PS, MOOE, Financial Expenses and Capital Outlay; (b) the priority development programs/projects and those to be funded by the 20% development fund, and; (c) disaster risk reduction management programs/projects/activities of the municipality. It further includes the following: 1) Gender and Development Plan, Peace and Order Plan and Anti-Drug Abuse Council Action Plan, Local Nutrition Action Plan, and Tourism/Cultural Development Plan, Climate Change Action Plan, Local Youth Development Plan, Annual Procurement Plan, and; 2) list of programs/projects/activities for the Local Council for Protection of Children, Senior Citizens and Persons with Disabilities, PPAs to combat Acquired Immune Deficiency Syndrome;

- 3. The proposed AIP has a total investment requirement of Php 448,501,896.00 which will be funded from the municipality's proposed 2025 Annual Budget which was approved and enacted by the Sangguniang Bayan on December 10, 2024 through Appropriation Ordinance No. 2024-04;
- 4. The development fund amounting to Php 45,460,379.20 which is allocated for development projects and debt servicing, is equivalent to 20% of the municipality's NTA amounting to Php 227,301,896.00 for CY 2025. This is in accordance with Section 287 of RA 7160;

The identified development programs/projects to be funded by the 20% of NTA are based on the DILG-DOF-DBM Joint Memorandum Circular No. 1 dated November 4, 2020 (Revised Guidelines on the Appropriation and Utilization of the 20% of the Annual Internal Revenue Allotment for Development Projects);

5. The identified programs/projects/activities to be funded by the 5% Local Disaster Risk Reduction and Management Fund of the municipality amounting to Php 22,425,094.80 conforms with Section 21 of RA 10121. The 70 % of the 5% LDRRMF amounting to Php 15,697,566.36 is allocated for disaster risk reduction programs/projects while 30 % on a total amount of Php 6,727,528.44 is set aside for Quick Response Fund. The programs, projects and activities proposed to be funded from 70 % of the 5 % LDRRMF are based on NDRRMC-DBM and DILG Joint Memo Circular No. 2013-1 dated March 25, 2013 (Allocation and Utilization of Local Disaster Risk Reduction and Management Fund). Further, the LDRRMF Plan 2020-2025 of the municipality was reviewed by the Office of Civil Defense (OCD) as per attached OCD Certification dated November 5, 2024. It is recommended however, that the 30 % of the 5 %

LDRRMF Quick Response Fund (QRF) shall be in lump-sum appropriation in accordance with Section 4.0 of above-cited JMC;

- 6. The LGU has also identified programs/projects/activities responsive to climate change and tagged its corresponding expenditures in their AIP. This is in pursuance to DBM-CCC-DILG Joint Memorandum Circular No. 2015-01 dated July 23, 2015.
- 7. The Gender and Development Plan of the municipality has been reviewed by the Department of the Interior and Local Government (DILG) and was found to be fully compliant in form and contents with the provisions of the PCW-DILG-DBM-NEDA Joint Memo Circular of 2016-01: Amendments to JMC 2013-01 re: Guidelines on Localization of the Magna Carta of Women as per attached Certificate of Review and Endorsement of the DILG dated January 3, 2025.

WHEREAS, the Sangguniang Panlalawigan, after final evaluation, finds the subject resolution in order, however, compliance with all the existing laws, rules and regulations shall be the responsibility of the Municipal Government of Binalonan, Pangasinan;

WHEREFORE, in view of the foregoing, on motion of SP Members Rosary Gracia P. Perez-Tababa and Nicholi Jan Louie Q. Sison and co-sponsored by SP Members Carolyn D. Sison, Joyce D. Fernandez and Raul R. Sabangan, duly seconded, it was—

**RESOLVED**, by the Sangguniang Panlalawigan in session assembled, to approve Resolution No. 2024-250 of the Sangguniang Bayan of Binalonan, Pangasinan, entitled "Adopting the Annual Investment Plan of the Municipality of Binalonan for Calendar Year 2025";
