DECLARING MUNICIPAL ORDINANCE NO. 205-100225 OF THE SANGGUNIANG BAYAN OF VILLASIS, PANGASINAN, ENTITLED "AN ORDINANCE REGULATING THE PROMOTION AND MARKETING OF BREASTMILK SUBSTITUTES AND BREASTMILK SUPPLEMENTS OR "THE MILK CODE" AND PROVIDING PENALTIES THEREOF" AS WITHIN THE CONFERRED POWERS OF THE SANGGUNIAN TO ENACT

WHEREAS, the Sangguniang Bayan of Villasis, Pangasinan submitted its Municipal Ordinance No. 205-100225 to the Sangguniang Panlalawigan for review and evaluation pursuant to Section 56 of Republic Act No. 7160, otherwise known as the Local Government Code of 1991;

WHEREAS, the Committee on Laws and Ordinances of the Sangguniang Panlalawigan with the technical assistance of the Provincial Legal Officer have conducted initial review and study on said ordinance and found out that the same was enacted in accordance with Sections 16, 17 (b) (2) (iii) and 447 (a) (5) (xiv) of Republic Act No. 7160; Sections 15, Article II (Principles), 11, Article XIII (Health) of the 1987 Philippine Constitution; Executive Order No. 51 or the "Milk Code"; Republic Act No. 11148 otherwise known as the "Kalusugan at Nutrisyon ng Mag-Nanay Act;

WHEREAS, the subject ordinance shall take effect after compliance with the requirement of publication pursuant to Section 511 (a) of R.A. No. 7160;
