RESOLUTION NO. 472-2025

DECLARING MUNICIPAL ORDINANCE NO. 207-100225 OF THE SANGGUNIANG BAYAN OF VILLASIS, PANGASINAN, ENTITLED “AN ORDINANCE AMENDING ARTICLE H SECTION 4H.01 (B) OF MUNICIPAL ORDINANCE NO. 172-171122, ENTITLED “THE UPDATED REVENUE CODE OF THE MUNICIPALITY OF VILLASIS, PROVINCE OF PANGASINAN, SERIES OF 2022” AS WITHIN THE CONFERRED POWERS OF THE SANGGUNIANG BAYAN TO ENACT

WHEREAS, the Sangguniang Bayan of Villasis, Pangasinan submitted its Municipal Ordinance No. 207-100225 to the Sangguniang Panlalawigan for review and evaluation pursuant to Section 56 of Republic Act No. 7160, otherwise known as the Local Government Code of 1991;

WHEREAS, the Committee on Laws and Ordinances of the Sangguniang Panlalawigan with the technical assistance of the Provincial Legal Officer have conducted initial review and study on said ordinance and found out that the power of the sangguniang bayan to enact ordinances and approve resolutions carries with it the power to amend, revoke, modify or repeal the same and in accordance with Section 447 (a) (3) (i) (vi) of Republic Act No. 7160;

WHEREAS, the subject ordinance shall take effect after compliance with the requirement of publication pursuant to Section 188 of R.A. No. 7160;


