APPROVING RESOLUTION NO. 2024-91 OF THE SANGGUNIANG BAYAN OF SAN MANUEL, PANGASINAN, ENTITLED “APPROVING SUPPLEMENTAL INVESTMENT PROGRAM NO. 2024-06 OF THE SUPPLEMENTAL BUDGET NO. 2024-06 OF THE MUNICIPALITY OF SAN MANUEL, PANGASINAN

WHEREAS, the Sangguniang Bayan of San Manuel, Pangasinan submitted its Resolution No. 2024-91 to the Sangguniang Panlalawigan for review and evaluation pursuant to Section 56 of the Republic Act No. 7160, otherwise known as the Local Government Code of 1991;

WHEREAS, the Committee on Laws and Ordinances of the Sangguniang Panlalawigan with the technical assistance of the Provincial Planning and Development Coordinator have conducted initial review and study on said Resolution with the following findings:

1. Subject resolution is in consonance to Sections 106, 109 and 114 of the Local Government Code (LGC) of 1991. The Local Development Council of San Manuel, Pangasinan has identified items in their Supplemental Annual Investment Program (SIP) No. 06 for CY 2024. This was endorsed to the Sangguniang Bayan on December 5, 2024 through MDC Resolution No. 07, Series of 2024;
2. The SIP No. 06 of the municipality covers fund augmentation for Personal Services (granting of Service Recognition Incentive (SRI) to municipal government employees) and Maintenance and Other Operating Expenses (MOOE) of the LGU San Manuel; and

4. Funding support for the proposed Supplemental Investment Program, with a total investment requirement of Php5,535,000.00 is embodied in the municipality's Supplemental Budget No. 06, CY 2024 which was approved and enacted by their Sangguniang Bayan through Appropriation Ordinance No. 07, Series of 2024 on December 11, 2024.


WHEREAS, the Sangguniang Panlalawigan, after final evaluation, finds the subject resolution in order, however, compliance with all the existing laws, rules and regulations shall be the responsibility of the Municipal Government of San Manuel, Pangasinan;


