RESOLUTION NO. 476-2025

DECLARING MUNICIPAL ORDINANCE NO. 204-100225 OF THE SANGGUNIANG BAYAN OF VILLASIS, PANGASINAN, ENTITLED “AN ORDINANCE PROVIDING FOR A MENTAL HEALTH PROGRAM IN THE MUNICIPALITY OF VILLASIS, PANGASINAN” AS WITHIN THE CONFERRED POWERS OF THE SANGGUNIAN TO ENACT

WHEREAS, the Sangguniang Bayan of Villasis, Pangasinan submitted its Municipal Ordinance No. 204-100225 to the Sangguniang Panlalawigan for review and evaluation pursuant to Section 56 of Republic Act No. 7160, otherwise known as the Local Government Code of 1991;

WHEREAS, the Committee on Laws and Ordinances of the Sangguniang Panlalawigan with the technical assistance of the Provincial Legal Officer and Local Finance Committee of the Province have conducted initial review and study on said municipal ordinance and found out that the same was enacted in accordance with Sections 15 and 37 of R.A. No. 11036 or the Mental Health Act and Section 16 of Republic Act No. 7160;

WHEREFORE, in view of the foregoing, on motion of SP Members Rosary Gracia P. Perez-Tababa and Nicholi Jan Louie Q. Sison and co-sponsored by SP Members Carolyn D. Sison, Joyce D. Fernandez and Raul R. Sabangan, duly seconded, it was—

RESOLVED, by the Sangguniang Panlalawigan in session assembled, to declare Municipal Ordinance No. 204-100225 of the Sangguniang Bayan of Villasis, Pangasinan, entitled “An Ordinance providing for a Mental Health Program in the Municipality of Villasis, Pangasinan” as within the conferred powers of the Sangguniang Bayan to enact;
