DECLARING MUNICIPAL ORDINANCE NO. 206-100225 OF THE SANGGUNIAN BAYAN OF VILLASIS, PANGASINAN, ENTITLED “AN ORDINANCE ADOPTING PROVINCIAL ORDINANCE NO. 329-2024 “INSTITUTIONALIZING THE NATIONAL IMMUNIZATION PROGRAM (NIP) REACHING EVERY PUROK (REP) STRATEGY IN THE PROVINCE OF PANGASINAN, PROVIDING FUNDS THEREFOR AND FOR OTHER PURPOSES” AS WITHIN THE CONFERRED POWERS OF THE SANGGUNIAN TO ENACT

WHEREAS, the Sangguniang Bayan of Villasis, Pangasinan submitted its Municipal Ordinance No. 206-100225 to the Sangguniang Panlalawigan for review and evaluation pursuant to Section 56 of Republic Act No. 7160, otherwise known as the Local Government Code of 1991;

WHEREAS, the Committee on Laws and Ordinances of the Sangguniang Panlalawigan with the technical assistance of the Provincial Legal Officer and Local Finance Committee of the Province have conducted initial review and study on said municipal ordinance and found out that the same was enacted in accordance with Section 15, Article II and Section 11, Article XIII of the 1987 Philippine Constitution, Sections 16, 17(b)(2)(iii) and 447(a)(5)(xiv) of Republic Act No. 7160 and Republic Act No. 10152 or the Mandatory Infants and Children Health Immunization Act of 2011;


