ADOPTING THE ENHANCED LOCAL DISASTER RISK REDUCTION AND MANAGEMENT PLAN FOR CALENDAR YEAR 2025-2033 OF THE PROVINCE OF PANGASINAN

WHEREAS, presented for consideration by the Sangguniang Panlalawigan is the Enhanced Local Disaster Risk Reduction and Management Plan (LDRRMP) for CY 2025-2033 of the Province of Pangasinan as adopted by the Provincial Disaster Risk Reduction and Management Council through PDRRMC Resolution No. 4, S-2025;

WHEREAS, the Enhanced Local Disaster Risk Reduction and Management Plan of the Province of Pangasinan contains a comprehensive and streamlined information on disaster management to be able to adopt with the climate-change and mitigate its adverse effects through proactive and coordinated efforts;
