PROVINCIAL RESOLUTION NO. 480-2025

AUTHORIZING THE PROVINCIAL GOVERNOR, RAMON V. GUICO III, TO ENTER INTO AND SIGN A MEMORANDUM OF AGREEMENT BY AND BETWEEN THE PROVINCE OF PANGASINAN AND THE TECHNICAL EDUCATION AND SKILLS DEVELOPMENT AUTHORITY (TESDA)-PROVINCIAL TRAINING CENTER-PANGASINAN IN THE IMPLEMENTATION OF A COMMUNITY-BASED TRAINING PROGRAM IN MASONRY NCII UNDER THE TRAINING FOR WORK SCHOLARSHIP PROGRAM

WHEREAS, the Provincial Training Center (PTC), overseen by the Technical Education and Skills Development Authority (TESDA), aims to provide accessible and high quality technical and vocational education and training programs that foster globally competitive, innovative and morally upright individuals who contribute to the socio-economic progress of their communities and nation;

WHEREAS, local government units are vested with the power under the Local Government Code of 1991 to apply their resources and assets for productive, developmental, or welfare purposes;

WHEREAS, the Province of Pangasinan and the TESDA, through the PTC, will jointly and voluntarily collaborate, using their respective resources, management and operation, in providing technical skills training to qualified recipients or beneficiaries such as, but not limited to, out-of- school youths, former/repatriated OFWs, drug surrenderers, persons deprived of liberty;

WHEREAS, both parties have agreed to provide trainings on Masonry NCII under Training for Work Scholarship Program (TWSP), subject to the terms and conditions stipulated under the MOA;

WHEREAS, for the above purpose, a Memorandum of Agreement shall be entered into and signed by and between the Province of Pangasinan, represented by Governor Ramon V. Guico III, and TESDA-Region 1, represented by Regional Director Joel M. Pilotin;

WHEREFORE, on motion of SP Member Napoleon C. Fontelera, Jr., duly seconded, it was -


