PROVINCIAL RESOLUTION NO. 482-2025

AUTHORIZING THE PROVINCIAL GOVERNOR, RAMON V. GUICO III, TO ENTER INTO AND SIGN A DEED OF TRANSFER WITH THE CITY GOVERNMENT OF BAGUIO FOR THE ACCEPTANCE AND TRANSFER OF OWNERSHIP OF LARVICIDES TO BE USED FOR THE DENGUE PREVENTION PROGRAM OF THE PROVINCE OF PANGASINAN

WHEREAS, the National Aedes-Borne Viral Diseases Prevention and Control Program (NAVDP) in the Philippines is a comprehensive initiative aimed at preventing and controlling diseases transmitted by Aedes mosquitoes, including dengue, Zika, and chikungunya;

WHEREAS, the Provincial Government of Pangasinan, through the Provincial Health Office, is presently implementing the aforesaid Program in order to closely monitor the ongoing dengue fever cases in the Province;

WHEREAS, according to the latest report from the Provincial Epidemiological & Surveillance Unit, the Provincial Health Office has recorded a total of 1,080 dengue cases from January 1 to April 21, 2025, which represents a 118% increase compared to the same period in 2024;

WHEREAS, one of the identified interventions to curb the transmission of dengue fever is the use of larvicides and insecticides for vector control in order to prevent the mosquito larvae and pupae to develop into adult mosquitoes, thereby decreasing the spread of disease;

WHEREAS, the City Government of Baguio has signified its intention to transfer larvicides to the Provincial Government of Pangasinan to support the promotion of the Province's public health, vector control, and disease prevention programs within its jurisdiction;

WHEREAS, the Provincial Government of Pangasinan will be the recipient of 712 bags of KITI-KITIX larvicides with active ingredients of Calcium Hydroxide 80% + Clinoptilolite 20% per 25 kg/bag from the City Government of Baguio;

WHEREAS, it is to the best interest of the Provincial Government of Pangasinan to sign a Deed of Transfer and accept the larvicides from the City Government of Baguio to further augment its disease prevention programs, especially this coming rainy season;


WHEREAS, for the above purpose, a Deed of Transfer shall be entered into and signed between the Province of Pangasinan, represented by Governor Ramon V. Guico III, and the City Government of Baguio, represented by City Mayor Benjamin B. Magalong;

NOW, THEREFORE, on motion of SP Member Napoleon C. Fontelera, Jr., duly seconded, it was –


RESOLVED, by the Sangguniang Panlalawigan in session assembled to authorize, as he is hereby authorized, the Provincial Governor, Ramon V. Guico III, to enter into and sign a Deed of Transfer with the City Government of Baguio for the acceptance and transfer of ownership of larvicides to be used for the Dengue Prevention Program of the Province of Pangasinan;
