RESOLUTION NO. 486-2025

DECLARING MUNICIPAL ORDINANCE NO. 06-2024 OF THE SANGGUNIANG BAYAN OF ANDA, PANGASINAN, ENTITLED “AN ORDINANCE RECLASSIFYING A PARCEL OF LAND CONTAINING AN AREA OF ELEVEN THOUSAND FIVE HUNDRED THIRTY-NINE SQUARE METERS (11,539 SQ. M.) BY TAX DECLARATION NO. 1745 LOCATED AT BARANGAY MACALEENG, ANDA, PANGASINAN FROM AGRICULTURAL LAND TO COMMERCIAL LAND FOR SPECIAL USE AS MEMORIAL PARK” AS WITHIN THE CONFERRED POWERS OF THE SANGGUNIAN TO ENACT

WHEREAS, the Sangguniang Bayan of Anda, Pangasinan submitted its Municipal Ordinance No. 06-2024 to the Sangguniang Panlalawigan for review and evaluation pursuant to Section 56 of Republic Act No. 7160, otherwise known as the Local Government Code of 1991;

WHEREAS, the Committee on Laws and Ordinances of the Sangguniang Panlalawigan with the technical assistance of the Provincial Legal Officer, Provincial Planning and Development Coordinator and the Department of Human Settlements and Urban Development have conducted initial review and study on said municipal ordinance and found out that the same was enacted pursuant to Sections 20 (a) (2) (3) (c) (d) (e) and 447 (a) (2) (viii) of R.A. No. 7160;

WHEREAS, the requisite of public hearing under Section 20 of the Local Government Code has been complied wherein concerned barangay official and residents posed no objection on the proposed establishment of a memorial park;

WHEREAS, the Municipality of Anda has an existing and approved Zoning Ordinance implementing its Comprehensive Land Use Plan CY 2023-2032;

WHEREAS, the Sangguniang Bayan submitted its Resolution No. 85-2023 (Resolution Proposing the Reclassification of a Parcel of Land Containing an area of Eleven Thousand Five Hundred Thirty-Nine Square Meters (11,539 sq. m.) Tax Declaration No. 1745 owned by Mrs. Gloria M. Andor Located at Barangay Macaleeng, Anda, Pangasinan from Agricultural Land to Commercial Land for Special Use as Memorial Park);

WHEREAS, Clearance for Reclassification (Certifications) from the Department of Agriculture and Department of Agrarian Reform are already accomplished and submitted to the Sangguniang Panlalawigan;


WHEREAS, the Department of Human Settlements and Urban Development endorsed the approval of the subject ordinance since the agricultural area subject of reclassification is still within the prescribed reclassification limit of the Municipality of Anda, Pangasinan;

WHEREFORE, in view of the foregoing, on motion of SP Member Napoleon C. Fontelera, Jr., duly seconded, it was—


RESOLVED, by the Sangguniang Panlalawigan in session assembled, to declare Municipal Ordinance No. 06-2024 of the Sangguniang Bayan of Anda, Pangasinan, entitled “An Ordinance reclassifying a parcel of land containing an area of eleven thousand five hundred thirty-nine square meters (11,539 sq. m.) by Tax Declaration No. 1745 located at Barangay Macaleeng, Anda, Pangasinan from Agricultural Land to Commercial Land for Special use as Memorial Park” as within the conferred powers of the Sangguniang Bayan to enact;
