PROVINCIAL RESOLUTION NO. 493-2025

AUTHORIZING THE PROVINCIAL GOVERNOR, RAMON V. GUICO III, TO ENTER INTO AND SIGN A MEMORANDUM OF AGREEMENT WITH METROWASTE SOLID WASTE MANAGEMENT CORPORATION FOR THE DISPOSAL OF THE PROVINCIAL GOVERNMENT'S RESIDUAL WASTE AT METROWASTE SANITARY LANDFILL FACILITY

WHEREAS, RA No. 7160, otherwise known as the Local Government Code of 1991, has vested upon local government units the authority to prescribe regulations aimed at promoting and preserving public health, order, safety and general welfare of its inhabitants;

WHEREAS, residual solid wastes are continuously generated and hauled by the Provincial Government, specifically from the Capitol Compound as well as from several provincial hospitals such as Mangatarem District Hospital, Eastern Pangasinan District Hospital, Lingayen District Hospital and Pangasinan Provincial Hospital, hence, there is a need for a sanitary landfill facility where these wastes will be disposed;

WHEREAS, Metrowaste Solid Waste Management Corporation (MWSWM), manages and operates an Engineered Sanitary Landfill in accordance with Republic Act 9003, located at the Urdaneta Waste Management Center at Barangay Catablan, Urdaneta City, Pangasinan, with ECC No. RO1-2403-0001, where all collected residual wastes from the Province will be transported and disposed;

WHEREAS, the duties and responsibilities of each party as well as the terms and conditions in the implementation of the program are already defined in the MOA;

WHEREAS, local government units are empowered under Section 22 (a) (5) (c) and Section 465 (vi) of RA 7160 to enter into contracts, but such power may be exercised with prior authorization emanating from the Sangguniang Panlalawigan through a resolution/ordinance;

NOW, THEREFORE, in view of the foregoing, on motion of SP Member Jerry Agerico B. Rosario, duly seconded, it was –


