**RESOLUTION NO. 505-2025**

**DECLARING MUNICIPAL ORDINANCE NO. 2025-03 OF THE SANGGUNANG BAYAN OF AGNO, PANGASINAN, ENTITLED “AN ORDINANCE ESTABLISHING THE GAWAD RAGPATEN SALUN-AT AWARDS, A HEALTH SERVICE RECOGNITION PROGRAM IN THE MUNICIPALITY OF AGNO, PROVINCE OF PANGASINAN” AS WITHIN THE CONFERRED POWERS OF THE SANGGUNIAN TO ENACT**

**WHEREAS**, the Sangguniang Bayan of Agno, Pangasinan submitted its Municipal Ordinance No. 2025-03 to the Sangguniang Panlalawigan for review and evaluation pursuant to Section 56 of Republic Act No. 7160, otherwise known as the Local Government Code of 1991;

**WHEREAS**, the Committee on Laws and Ordinances of the Sangguniang Panlalawigan with the technical assistance of the Provincial Legal Officer have conducted initial review and study on said municipal ordinance and found out that the same was enacted in accordance with Section 16 of Republic Act No. 7160;

**WHEREAS**, the subject ordinance shall take effect after compliance with the requirement of posting pursuant to Section 59 (a) of R.A. No. 7160;

**WHEREFORE**, in view of the foregoing, on motion of SP Member Napoleon C. Fontelera, Jr., duly seconded, it was—

**RESOLVED**, by the Sangguniang Panlalawigan in session assembled, to declare Municipal Ordinance No. 2025-03 of the Sangguniang Bayan of Agno, Pangasinan, entitled “An Ordinance establishing the Gawad Ragpaten Salun-At Awards, a Health Service Recognition Program in the Municipality of Agno, Province of Pangasinan” as within the conferred powers of the Sangguniang Bayan to enact;


