RESOLUTION NO. 511-2025

DECLARING MUNICIPAL ORDINANCE NO. 08-2024 OF THE SANGGUNANG BAYAN OF ANDA, PANGASINAN, ENTITLED “AN ORDINANCE REGULATING THE USE, SALE, DISTRIBUTION AND ADVERTISEMENT OF CIGARETTES AND OTHER TOBACCO PRODUCTS, ELECTRONIC NICOTINE AND NON-NICOTINE DELIVERY SYSTEMS, HEATED TOBACCO PRODUCTS AND OTHER NOVEL TOBACCO PRODUCTS IN CERTAIN PLACES IMPOSING PENALTIES FOR VIOLATIONS THEREOF AND PROVIDING FUNDS THEREFORE TO INSTILL HEALTH CONSCIOUSNESS AND FOR OTHER PURPOSES IN THE MUNICIPALITY OF ANDA, PANGASINAN” AS WITHIN THE CONFERRED POWERS OF THE SANGGUNIAN TO ENACT

WHEREAS, the Sangguniang Bayan of Anda, Pangasinan submitted its Municipal Ordinance No. 08-2024 to the Sangguniang Panlalawigan for review and evaluation pursuant to Section 56 of Republic Act No. 7160, otherwise known as the Local Government Code of 1991;

WHEREAS, the Committee on Laws and Ordinances of the Sangguniang Panlalawigan with the technical assistance of the Provincial Legal Officer have conducted initial review and study on said municipal ordinance and found out that the same was enacted in accordance with Tobacco Regulation Act of 2003 (R.A. 9211), Sections 16, 447 (a)(1)(iii) of Republic Act No. 7160, Executive Order No. 26 entitled “Providing for Establishments of Smoke-Free Environments in Public and Enclosed Places” and Republic Act No. 8749, “The Philippine Clean Air Act of 1999”;

WHEREAS, the subject ordinance shall take effect after compliance with the requirement of publication pursuant to Section 511 (a) of R.A. No. 7160;

RESOLVED, by the Sangguniang Panlalawigan in session assembled, to declare Municipal Ordinance No. 08-2024 of the Sangguniang Bayan of Anda, Pangasinan, entitled “An Ordinance regulating the use, sale, distribution and advertisement of cigarettes and other tobacco products, electronic nicotine and non-nicotine delivery systems, heated tobacco products and other novel tobacco products in certain places imposing penalties for violations thereof and providing funds therefore to instill health consciousness and for other purposes in the Municipality of Anda, Pangasinan” as within the conferred powers of the Sangguniang Bayan to enact;
