RESOLUTION NO. 512-2025

APPROVING RESOLUTION NO. 47, S-2025 OF THE SANGGUNIANG BAYAN OF INFANTA, PANGASINAN, ENTITLED "APPROVING THE FIRST SUPPLEMENTAL ANNUAL INVESTMENT PROGRAM (AIP) FOR CALENDAR YEAR 2025 OF THE MUNICIPALITY OF INFANTA, PANGASINAN"

WHEREAS, the Sangguniang Bayan of Infanta, Pangasinan submitted its Resolution No. 47, S-2025 to the Sangguniang Panlalawigan for review and evaluation pursuant to Section 56 of the Republic Act No. 7160, otherwise known as the Local Government Code of 1991;

WHEREAS, the Committee on Laws and Ordinances of the Sangguniang Panlalawigan with the technical assistance of the Provincial Planning and Development Coordinator have conducted initial review and study on said Resolution with the following findings:

- 1. Subject resolution is in consonance to Sections 106, 109 and 114 of the Local Government Code of 1991. The Local Development Council of Infanta, Pangasinan has identified items in their First Supplemental Annual Investment Program (SAIP) for CY 2025. This was endorsed to the Sangguniang Bayan on February 21, 2025 through MDC Resolution No. 1, Series 2025;
- 2. The SAIP No. 01 covers fund augmentation for the Personal Services, Maintenance and Other Operating Expenses and Capital Outlay of some municipal offices, and implementation of development projects and disaster risk reduction and management programs/projects/activities of the LGU; and

3. Funding support for the proposed SAIP, with a total investment requirement of PhP32,260,110.28, is embodied in the municipality's Supplemental Budget No. 1 CY 2025, amounting to PhP19,015,061.34, which was approved and *enacted by their Sangguniang Bayan on March 3, 2025* through *Appropriation Ordinance No. 01, Series of 2025*. The remaining Php13,245,048.94 will be funded under the BFP Trust Fund (PhP280,528.94), Konsulta Trust Fund (PhP1,811,520.00), LGSF-FALGU (PhP10,000,000.00), and SGLGIF FY 2024 (PhP1,153,000.00).

WHEREAS, the Sangguniang Panlalawigan, after final evaluation, finds the subject resolution in order, however, compliance with all the existing laws, rules and regulations shall be the responsibility of the Municipal Government of Infanta, Pangasinan;

WHEREFORE, in view of the foregoing, on motion of SP Member Napoleon C. Fontelera, Jr., duly seconded, it was—

RESOLVED, by the Sangguniang Panlalawigan in session assembled, to approve Resolution No. 47, S-2025 of the Sangguniang Bayan of Infanta, Pangasinan, entitled "Approving the First Supplemental Annual Investment Program (AIP) for Calendar Year 2025 of the Municipality of Infanta, Pangasinan";

RESOLVED FURTHER, that a copy of this resolution be furnished the Office of the Sangguniang Bayan of Infanta, Pangasinan, for its information and guidance.
