RESOLUTION NO. 514-2025

APPROVING RESOLUTION NO. 71, S-2025 OF THE SANGGUNIANG BAYAN OF INFANTA, PANGASINAN, ENTITLED “APPROVING THE SECOND SUPPLEMENTAL ANNUAL INVESTMENT PROGRAM (AIP) FOR CALENDAR YEAR 2025 OF THE MUNICIPALITY OF INFANTA, PANGASINAN”

WHEREAS, the Sangguniang Bayan of Infanta, Pangasinan submitted its Resolution No. 71, S-2025 to the Sangguniang Panlalawigan for review and evaluation pursuant to Section 56 of the Republic Act No. 7160, otherwise known as the Local Government Code of 1991;

WHEREAS, the Committee on Laws and Ordinances of the Sangguniang Panlalawigan with the technical assistance of the Provincial Planning and Development Coordinator have conducted initial review and study on said Resolution with the following findings:

1. Subject resolution is in consonance to Sections 106, 109 and 114 of the Local Government Code of 1991. The Local Development Council of Infanta, Pangasinan has identified items in their Second Supplemental Annual Investment Program (SAIP) for CY 2025. This was endorsed to the Sangguniang Bayan on April 10, 2025 through MDC Resolution No. 2, Series 2025;
2. The SAIP No. 02 covers fund augmentation for the Personal Services, Maintenance and Other Operating Expenses of some municipal offices, and implementation of disaster risk reduction and management programs/projects/activities of the LGU; and

3. Funding support for the proposed SAIP, with a total investment requirement of PhP3,622,937.00, is embodied in the municipality's Supplemental Budget No. 2 CY 2025, amounting to PhP673,967.00, which was approved and enacted by their Sangguniang Bayan on April 14, 2025 through Appropriation Ordinance No. 02, Series of 2025. The remaining PhP2,948,970.00 will be funded under the Konsulta Trust Fund.


