### **RESOLUTION NO. 516-2025**

#### APPROVING RESOLUTION NO. 50-S-2025 OF THE SANGGUNIANG OF AGUILAR, PANGASINAN, ENTITLED "APPROVING THE SUPPLEMENTAL ANNUAL INVESTMENT PLAN OF SUPPLEMENTAL BUDGET NO. 1, CY 2025 OF THE MUNICIPALITY OF AGUILAR, PANGASINAN"

WHEREAS, the Sangguniang Bayan of Aguilar, Pangasinan submitted its Resolution No. 50-S-2025 to the Sangguniang Panlalawigan for review and evaluation pursuant to Section 56 of the Republic Act No. 7160, otherwise known as the Local Government Code of 1991;

WHEREAS, the Committee on Laws and Ordinances of the Sangguniang Panlalawigan with the technical assistance of the Provincial Planning and Development Officer of the Pangasinan has conducted initial review and study on said Resolution with the following findings:

- 1. The Municipal Development Council of Aguilar, Pangasinan prepared their Supplemental Annual Investment Program (SAIP) No. 1 for FY 2025. This was endorsed by the Council, through MDC Executive Committee Resolution No. 3, S-2025 dated April 11, 2025, to the Sangguniang Bayan for approval. This is in accordance with Sections 106, 109 and 114 of the Local Government Code of 1991;
- Said Supplemental AIP, which has a total investment requirement of P8,756,364.31, covers the augmentation of funds for Personal Services, Maintenance and Other Operating Expenses and Capital Outlay of various offices of the LGU, and implementation of LDRRM projects of the municipality;

- The project proposed to be funded from the 5% LDRRM Fund conform with Joint Memorandum Circular No. 2013-1 of the NDRRMC, DBM & DILG dated March 25, 2013 (Allocation and Utilization of the Local Disaster Risk Reduction and Management Fund); and
- 4. Funding for the Supplemental AIP is embodied in the LGU's Supplemental Budget No. 1 for FY 2025, which was enacted by their Sangguniang Bayan through Appropriation Ordinance No. 01, Series of 2025 dated April 14, 2025.

WHEREAS, the Sangguniang Panlalawigan, after final evaluation, finds the subject resolution in order, however, compliance with all the existing laws, rules and regulations shall be the responsibility of the Municipal Government of Aguilar, Pangasinan;

**WHEREFORE**, in view of the foregoing, on motion of SP Member Napoleon C. Fontelera, Jr., duly seconded, it was-

**RESOLVED**, by the Sangguniang Panlalawigan in session assembled, to approve Resolution No. 50-S-2025 of the Sangguniang of Aguilar, Pangasinan, entitled "Approving the Supplemental Annual Investment Plan of Supplemental Budget No. 1, CY 2025 of the Municipality of Aguilar, Pangasinan;
