#### **RESOLUTION NO. 518-2025**

DECLARING MUNICIPAL ORDINANCE NO. 58, S-2025 OF THE SANGGUNIANG BAYAN OF AGUILAR, PANGASINAN, ENTITLED "THE MUNICIPAL ENVIRONMENT CODE OF AGUILAR, PANGASINAN" AS WITHIN THE CONFERRED POWERS OF THE SANGGUNIAN TO ENACT

**WHEREAS**, the Sangguniang Bayan of Aguilar, Pangasinan submitted its Ordinance No. 58, S-2025 to the Sangguniang Panlalawigan for review and evaluation pursuant to Section 56 of Republic Act No. 7160, otherwise known as the Local Government Code of 1991;

WHEREAS, the Committee on Laws and Ordinances of the Sangguniang Panlalawigan with the technical assistance of the Provincial Legal Officer has conducted initial review and study on said ordinance and found out that the same was enacted in accordance with R.A. No. 8749 or Clean Air Act of 1999; R.A. No. 9003 or Solid Waste Management Act; R.A. No. 9275 or Clean Water Act; and Sections 16, 17(a)(2)(vi), and 447(1)(iii)(vi) of R.A. No. 7160;

**WHEREAS**, the subject ordinance shall take effect after compliance with the requirement of publication pursuant to Section 511 (a) of R.A. No. 7160;

**WHEREFORE**, in view of the foregoing, on motion of SP Member Napoleon C. Fontelera, Jr., duly seconded, it was—

**RESOLVED,** by the Sangguniang Panlalawigan in session assembled, to declare Municipal Ordinance No. 58, S-2025 of the Sangguniang Bayan of Aguilar, Pangasinan, entitled "The Municipal Environment Code of Aguilar, Pangasinan" as within the conferred powers of the Sangguniang Bayan to enact;
