RESOLUTION NO. 519-2025

DECLARING ORDINANCE NO. 233, S-2025 OF THE SANGGUNANG OF BASISTA, PANGASINAN, ENTITLED “AN ORDINANCE INSTITUTIONALIZING THE GRANTING OF CASH ASSISTANCE AND INSURANCE BENEFITS TO REGISTERED FARMERS OF THE MUNICIPALITY OF BASISTA, PANGASINAN” AS WITHIN THE CONFERRED POWERS OF THE SANGGUNIAN TO ENACT

WHEREAS, the Sangguniang Bayan of Basista, Pangasinan submitted its Ordinance No. 233, S-2025 to the Sangguniang Panlalawigan for review and evaluation pursuant to Section 56 of Republic Act No. 7160, otherwise known as the Local Government Code of 1991;

WHEREAS, the Committee on Laws and Ordinances of the Sangguniang Panlalawigan with the technical assistance of the Provincial Legal Officer and the Local Finance Committee of the Province has conducted initial review and study on said ordinance and found out that the same was enacted in accordance with Section 16 of R.A. No. 7160, and R.A. No. 11321, otherwise known as the “Sagip Saka Act”;

WHEREFORE, in view of the foregoing, on motion of SP Member Napoleon C. Fontelera, Jr., duly seconded, it was—

RESOLVED, by the Sangguniang Panlalawigan in session assembled, to declare Ordinance No. 233, S-2025 of the Sangguniang of Basista, Pangasinan, entitled “an Ordinance institutionalizing the granting of cash assistance and insurance benefits to registered farmers of the Municipality of Basista, Pangasinan” as within the conferred powers of the Sangguniang Bayan to enact;
