RESOLUTION NO. 523-2025

DECLARING ORDINANCE NO. 39, S-2024 OF THE SANGGUNIANG BAYAN OF LINGAYEN, PANGASINAN, ENTITLED "AN ORDINANCE ESTABLISHING THE POPULATION PROGRAM OFFICE IN THE MUNICIPALITY OF LINGAYEN, PANGASINAN" AS WITHIN THE CONFERRED POWERS OF THE SANGGUNIAN TO ENACT

WHEREAS, the Sangguniang Bayan of Lingayen, Pangasinan submitted its Ordinance No. 39, S-2024 to the Sangguniang Panlalawigan for review and evaluation pursuant to Section 56 of Republic Act No. 7160, otherwise known as the Local Government Code of 1991;

WHEREAS, the Committee on Laws and Ordinances of the Sangguniang Panlalawigan with the technical assistance of the Provincial Legal Officer, the Civil Service Commission, and the Local Finance Committee of the Province has conducted initial review and study on said ordinance and found out that the same was enacted in accordance with Sections 443(c)(2), and 447(a)(1)(vi)(viii) of R.A. No. 7160; Sections 5, 6, 9 and 12 of CSC Memorandum Circular No. 12-2022 (2022 Guidelines and Standards in the Establishment of Organization Structures and Staffing Patterns in the Local Government Units);

WHEREFORE, in view of the foregoing, on motion of SP Member Napoleon C. Fontelera, Jr., duly seconded, it was—

RESOLVED, by the Sangguniang Panlalawigan in session assembled, to declare Municipal Ordinance No. 39, S-2024 of the Sangguniang Bayan of Lingayen, Pangasinan, entitled "An Ordinance establishing the Population Program Office in the Municipality of Lingayen, Pangasinan" as within the conferred powers of the Sangguniang Bayan to enact;
