RESOLUTION NO. 524-2025

ORDINANCE OF THE DECLARING NO. 048, S-2025 **OF** PANGASINAN. LINGAYEN, **SANGGUNIANG BAYAN** ENTITLED "AN ORDINANCE ADOPTING AND IMPLEMENTING THE PROVISIONS OF REPUBLIC ACT NO. 11642, OTHERWISE KNOWN AS THE DOMESTIC ADMINISTRATIVE ADOPTION AND ALTERNATIVE CHILD CARE ACT OF 2021, WITHIN THE MUNICIPALITY OF LINGAYEN, AND PROVIDING FOR THE **GUIDELINES AND MECHANISMS NECESSARY** IN IMPLEMENTATION THEREOF" AS WITHIN THE CONFERRED POWERS OF THE SANGGUNIAN TO ENACT

WHEREAS, the Sangguniang Bayan of Lingayen, Pangasinan submitted its Ordinance No. 048, S-2025 to the Sangguniang Panlalawigan for review and evaluation pursuant to Section 56 of Republic Act No. 7160, otherwise known as the Local Government Code of 1991;

WHEREAS, the Committee on Laws and Ordinances of the Sangguniang Panlalawigan with the technical assistance of the Provincial Legal Officer has conducted initial review and study on said ordinance and found out that the same was enacted in accordance with Section 443 (c) (2) of R.A. No. 7160 and R.A. No. 11642 or the Domestic Administrative Adoption and Alternative Child Care Act;

WHEREFORE, in view of the foregoing, on motion of SP Member Napoleon C. Fontelera, Jr., duly seconded, it was—

RESOLVED, by the Sangguniang Panlalawigan in session assembled, to declare Ordinance No. 048, S-2025 of the Sangguniang Bayan of Lingayen, Pangasinan, entitled "An Ordinance adopting and implementing the provisions of Republic Act No. 11642, otherwise known as the Domestic Administrative Adoption and Alternative Child Care Act of 2021, within the Municipality of Lingayen, and providing for the necessary
