RESOLUTION NO. 525-2025

DECLARING ORDINANCE NO. 052, S-2025 OF THE SANGGUNANG BAYAN OF LINGAYEN, PANGASINAN, ENTITLED “AN ORDINANCE ADOPTING THE 2025 CHILDREN’S CODE OF THE MUNICIPALITY OF LINGAYEN, PANGASINAN” AS WITHIN THE CONFERRED POWERS OF THE SANGGUNIAN TO ENACT

WHEREAS, the Sangguniang Bayan of Lingayen, Pangasinan submitted its Ordinance No. 052, S-2025 to the Sangguniang Panlalawigan for review and evaluation pursuant to Section 56 of Republic Act No. 7160, otherwise known as the Local Government Code of 1991;

WHEREAS, the Committee on Laws and Ordinances of the Sangguniang Panlalawigan with the technical assistance of the Provincial Legal Officer has conducted initial review and study on said ordinance and found out that the same was enacted in accordance with the Presidential Decree 603 or the Child and Youth Welfare Code, United Nations Convention on the Rights of the Child (CRC), R.A. No. 7610 of 1992 (Special Protection of Children Against Child Abuse, Exploitation, and Discrimination Act), and Sections 17(b)(2)(iii)(iv)(5)(xiv) and 447 (a)(1)(iii) of R.A. No. 7160;

WHEREAS, subject ordinance shall take effect after compliance with the requirement of publication pursuant to Section 511 (a) R.A. No. 7160;

WHEREFORE, in view of the foregoing, on motion of SP Member Napoleon C. Fontelera, Jr., duly seconded, it was—
