#### **RESOLUTION NO. 527-2025**

APPROVING RESOLUTION NO. 14, S-2025 OF THE SANGGUNIANG BAYAN OF CALASIAO, PANGASINAN, ENTITLED "APPROVING THE SUPPLEMENTAL ANNUAL INVESTMENT PROGRAM (SAIP) NO. 1 OF THE MUNICIPALITY OF CALASIAO, FOR THE YEAR 2025"

WHEREAS, the Sangguniang Bayan of Calasiao, Pangasinan submitted its Resolution No. 14, S-2025 to the Sangguniang Panlalawigan for review and evaluation pursuant to Section 56 of the Republic Act No. 7160, otherwise known as the Local Government Code of 1991;

WHEREAS, the Committee on Laws and Ordinances of the Sangguniang Panlalawigan with the technical assistance of the Provincial Planning and Development Officer have conducted initial review and study on said Resolution with the following findings:

- The Municipal Development Council of Calasiao, Pangasinan prepared the municipality's Supplemental Annual Investment Program No. 1 for CY 2025. This was endorsed by the Council, through MDC Resolution No. 1, Series of 2025 dated January 31, 2025, to the Sangguniang Bayan for approval. This is in accordance with Sections 106, 109 and 114 of the Local Government Code of 1991;
- 2. Said Supplemental Annual Investment Program, which has a total investment requirement of P10,186,766.06, covers the augmentation of funds for Personal Services (Implementation of the Second Tranche of the Salary Increase for Municipal Officials and Employees effective September 2025), Maintenance and Other Operating Expenses (MOOE) and Capital Outlay (CO) of some offices of the LGU, and implementation of other priority projects of the municipality; and

3. Funding support for the implementation of the Supplemental AIP is embodied in the LGU's Supplemental Budget No. 01, FY 2025, which was enacted by their Sangguniang Bayan through Appropriation Ordinance No. 02, Series of 2025 dated February 10, 2025.

WHEREAS, the Sangguniang Panlalawigan, after final evaluation, finds the subject resolution in order, however, compliance with all the existing laws, rules and regulations shall be the responsibility of the Municipal Government of Calasiao, Pangasinan;
