RESOLUTION NO. 532-2025

DECLARING ORDINANCE NO. 2025-059 OF THE SANGGUNIANG BAYAN OF STA. BARBARA, PANGASINAN, ENTITLED “AN ORDINANCE ABOLISHING THE VACANT POSITION OF ENVIRONMENTAL MANAGEMENT SPECIALIST I, SALARY GRADE 11 AND SUBSEQUENTLY CREATING THE POSITION OF ADMINISTRATIVE ASSISTANT V (DATA CONTROLLER III) SALARY GRADE 11 UNDER THE MUNICIPAL ENVIRONMENT AND NATURAL RESOURCES OFFICE (MENRO) OF THE MUNICIPALITY OF STA. BARBARA, PANGASINAN” AS WITHIN THE CONFERRED POWERS OF THE SANGGUNIAN TO ENACT

WHEREAS, the Sangguniang Bayan of Sta. Barbara, Pangasinan submitted its Municipal Ordinance No. 2025-059 to the Sangguniang Panlalawigan for review and evaluation pursuant to Section 56 of Republic Act No. 7160, otherwise known as the Local Government Code of 1991;

WHEREAS, the Committee on Laws and Ordinances of the Sangguniang Panlalawigan with the technical assistance of the Local Finance Committee of the Province have conducted initial review and study on said municipal ordinance and found out that the same was enacted in accordance with Sections 76 & 447 (a) (1) (viii) of R.A. No. 7160;

WHEREFORE, in view of the foregoing, on motion of SP Member Napoleon C. Fontelera, Jr., duly seconded, it was—

RESOLVED, by the Sangguniang Panlalawigan in session assembled, to declare Municipal Ordinance No. 2025-059 of the Sangguniang Bayan of Sta. Barbara, Pangasinan, entitled “An Ordinance abolishing the vacant position of Environmental Management Specialist I, Salary Grade 11 and subsequently creating the position of Administrative Assistant V (Data Controller III), Salary Grade 11, under the Municipal
