**RESOLUTION NO. 533-2025**

**DECLARING MUNICIPAL ORDINANCE NO. 2025-01 OF THE SANGGUNIANG BAYAN OF MANGALDAN, PANGASINAN, ENTITLED “AN ORDINANCE AMENDING CHAPTER VII, ARTICLE XIII, SECTION 1 ON THE COMPREHENSIVE PUBLIC ORDER, SAFETY, AND TRAFFIC MANAGEMENT CODE OF THE MUNICIPALITY OF MANGALDAN, PANGASINAN ALLOWING INDEPAK DRIVERS AND MOTOR TRICYCLE DRIVERS TO TRAVERSE RIZAL AVENUE ALONG THE COMMERCIAL BUSINESS DISTRICT OF MANGALDAN” AS WITHIN THE CONFERRED POWERS OF THE SANGGUNIAN TO ENACT**

**WHEREAS**, the Sangguniang Bayan of Mangaldan, Pangasinan submitted its Municipal Ordinance No. 2025-01 to the Sangguniang Panlalawigan for review and evaluation pursuant to Section 56 of Republic Act No. 7160, otherwise known as the Local Government Code of 1991;

**WHEREAS**, the Committee on Laws and Ordinances of the Sangguniang Panlalawigan with the technical assistance of the Provincial Legal Officer conducted initial review and study on said municipal ordinance and found out that the same was enacted in accordance with Sections 16 & 447 (a) (1) (iii) (3) (vi) (5) (v) (vi) of R.A. No. 7160; and DILG Memorandum Circular No. 2020-036;

**WHEREFORE**, in view of the foregoing, on motion of SP Member Napoleon C. Fontelera, Jr., duly seconded, it was—

**RESOLVED**, by the Sangguniang Panlalawigan in session assembled, to declare Municipal Ordinance No. 2025-01 of the Sangguniang Bayan of Mangaldan, Pangasinan, entitled “An Ordinance amending Chapter VII, Article XIII, Section 1 on the Comprehensive Public Order, Safety, and Traffic Management Code of the Municipality of Mangaldan, Pangasinan allowing *indepak* drivers and motor tricycle drivers to traverse
