RESOLUTION NO. 534-2025

DECLARING MUNICIPAL ORDINANCE NO. 2025-02 OF THE SANGGUNIANG BAYAN OF MANGALDAN, PANGASINAN, ENTITLED "AN ORDINANCE INSTITUTIONALIZING THE GRANT OF MEDICAL ALLOWANCE TO ALL LOCAL GOVERNMENT UNIT (LGU) EMPLOYEES OF MANGALDAN, PANGASINAN AND APPROPRIATING FUNDS THEREOF" AS WITHIN THE CONFERRED POWERS OF THE SANGGUNIAN TO ENACT

WHEREAS, the Sangguniang Bayan of Mangaldan, Pangasinan submitted its Municipal Ordinance No. 2025-02 to the Sangguniang Panlalawigan for review and evaluation pursuant to Section 56 of Republic Act No. 7160, otherwise known as the Local Government Code of 1991;

WHEREAS, the Committee on Laws and Ordinances of the Sangguniang Panlalawigan with the technical assistance of the Provincial Legal Office and the Local Finance Committee of the Province have conducted initial review and study on said municipal ordinance and found out that the same was enacted in accordance with Sections 16 & 447 (a) (1) (viii) of R.A. No. 7160; and Executive Order No. 64, entitled "Updating the Salary Schedule for Civilian Government Personnel and Authorizing the Grant of an Additional Allowance, and For Other Purposes";

WHEREFORE, in view of the foregoing, on motion of SP Member Napoleon C. Fontelera, Jr., duly seconded, it was—

RESOLVED, by the Sangguniang Panlalawigan in session assembled, to declare Municipal Ordinance No. 2025-02 of the Sangguniang Bayan of Mangaldan, Pangasinan, entitled "An Ordinance Institutionalizing the Grant of Medical Allowance to all Local Government Unit (LGU) Employees of Mangaldan, Pangasinan and Appropriating Funds Thereof" as within the conferred powers of the Sangguniang Bayan to enact;
