APPROVING RESOLUTION NO. 2025-47 OF THE SANGGUNIANG BAYAN OF MANGALDAN, PANGASINAN, ENTITLED "APPROVING AND ADOPTING THE SUPPLEMENTAL ANNUAL INVESTMENT PROGRAM (AIP) NO. 2, CY 2025 OF THE MUNICIPALITY OF MANGALDAN, PANGASINAN"

WHEREAS, the Sangguniang Bayan of Mangaldan, Pangasinan submitted its Resolution No. 2025-47 to the Sangguniang Panlalawigan for review and evaluation pursuant to Section 56 of the Republic Act No. 7160, otherwise known as the Local Government Code of 1991;

WHEREAS, the Committee on Laws and Ordinances of the Sangguniang Panlalawigan with the technical assistance of the Provincial Planning and Development Officer have conducted initial review and study on said Resolution with the following findings:

- Subject Resolution is in consonance to Sections 106, 109, and 114 of the Local Government Code (LGC) of 1991. The Local Development Council of Mangaldan, Pangasinan has identified items in the Supplemental Investment Program (SIP) No. 2, CY 2025. This was endorsed to the Sangguniang Bayan for approval on February 24, 2025, by the Municipal Development Council-Executive Committee thru Resolution No. 2, Series of 2025;
- Said Supplemental AIP, which has an investment requirement of [₽]2,025,000.00, covers fund augmentation Maintenance and Other Operating Expenses (MOOE) of the LGU; and

> 3. Funding for the full implementation of the Supplemental AIP is embodied in the LGU's Supplemental Budget No. 2, CY-2025, which was enacted by their Sangguniang Bayan through Appropriation Ordinance No. 2025-02 dated March 6, 2025 and approved by the Municipal Mayor on March 12, 2025.

WHEREAS, the Sangguniang Panlalawigan, after final evaluation, finds the subject resolution in order, however, compliance with all the existing laws, rules and regulations shall be the responsibility of the Municipal Government of Mangaldan, Pangasinan;

WHEREFORE, in view of the foregoing, on motion of SP Member Napoleon C. Fontelera, Jr., duly seconded, it was-

RESOLVED, by the Sangguniang Panlalawigan in session assembled, to approve Resolution No. 2025-47 of the Sangguniang Bayan of Mangaldan, Pangasinan, entitled "Approving and Adopting the Supplemental Annual Investment Program (AIP) No. 2, CY 2025 of the Municipality of Mangaldan, Pangasinan";
