APPROVING RESOLUTION NO. 449, S-2025 OF THE SANGGUNIAN BAYAN OF BAUTISTA, PANGASINAN, ENTITLED "APPROVING THE MUNICIPAL DEVELOPMENT COUNCIL RESOLUTION NO. 2, SERIES OF 2025 THE SUPPLEMENTAL ANNUAL INVESTMENT PROGRAM AMOUNTING TO TWENTY THREE MILLION FIVE HUNDRED FOURTEEN THOUSAND NINE HUNDRED FIFTY PESOS AND 27/100 (P23,514,950.27)"

WHEREAS, the Sangguniang Bayan of Bautista, Pangasinan submitted its Resolution No. 449, S-2025 to the Sangguniang Panlalawigan for review and evaluation pursuant to Section 56 of the Republic Act No. 7160, otherwise known as the Local Government Code of 1991;

WHEREAS, the Committee on Laws and Ordinances of the Sangguniang Panlalawigan with the technical assistance of the Provincial Planning and Development Officer have conducted initial review and study on said Resolution with the following findings:

1. Subject resolution is in consonance with Sections 106, 109 and 114 of the Local Government Code (LGC) of 1991. The Municipal Development Council of Bautista, Pangasinan has identified items in their Supplemental Annual Investment Program No. 2. This was endorsed to the Sangguniang Bayan for approval on March 18, 2025 by the Municipal Development Council-Executive Committee through Resolution No. 3, S. of 2025;
2. The SAIP covers fund augmentation for the Maintenance and Other Operating Expenses (MOOE) and Capital Outlay of some municipal offices and implementation of priority projects of the LGU; and

3. Funding support for the full implementation of the same in the amount of ₱23,514,950.27, is embodied in their Supplemental Budget No. 2 for CY 2025 which was enacted by their Sangguniang Bayan thru Appropriation Ordinance No. 2, S. of 2025 on March 24, 2025.


WHEREAS, the Sangguniang Panlalawigan, after final evaluation, finds the subject resolution in order, however, compliance with all the existing laws, rules and regulations shall be the responsibility of the Municipal Government of Bautista, Pangasinan;

WHEREFORE, in view of the foregoing, on motion of SP Member Napoleon C. Fontelera, Jr., duly seconded, it was—

RESOLVED, by the Sangguniang Panlalawigan in session assembled, to approve Resolution No. 449, S-2025 of the Sangguniang Bayan of Bautista, Pangasinan, entitled “Approving the Municipal Development Council Resolution No. 2, Series of 2025, the Supplemental Annual Investment Program amounting to Twenty Three Million Five Hundred Fourteen Thousand Nine Hundred Fifty Pesos and 27/100 (P23,514,950.27)”;
