**RESOLUTION NO. 539-2025**

**APPROVING RESOLUTION NO. 2025-032 OF THE SANGGUNIANG BAYAN OF LAOAC, PANGASINAN, ENTITLED “APPROVING THE SUPPLEMENTAL ANNUAL INVESTMENT PLAN (SAIP) NO. 2 FOR CALENDAR YEAR 2025 OF THE MUNICIPALITY OF LAOAC, PANGASINAN AMOUNTING TO ONE MILLION ONE HUNDRED EIGHTY-THREE THOUSAND PESOS (P1,183,000.00)”**

**WHEREAS**, the Sangguniang Bayan of Laoac, Pangasinan submitted its Resolution No. 2025-032 to the Sangguniang Panlalawigan for review and evaluation pursuant to Section 56 of the Republic Act No. 7160, otherwise known as the Local Government Code of 1991;

**WHEREAS**, the Committee on Laws and Ordinances of the Sangguniang Panlalawigan with the technical assistance of the Provincial Planning and Development Officer have conducted initial review and study on said Resolution with the following findings:

1. Subject resolution is in consonance to Sections 106, 109 and 114 of the Local Government Code (LGC) of 1991. The Municipal Development Council of Laoac, Pangasinan has identified items in their Supplemental Investment Program No. 2. This was endorsed to the Sangguniang Bayan for approval on March 3, 2025 by the Municipal Development Council-Executive Committee through Resolution No. 2025-01;
2. The SAIP covers fund augmentation for Personal Services (granting of Medical Allowance to qualified LGU officials and employees) with the total investment requirement of Php1,183,000.00; and

3. Funding support for the full implementation of the same is embodied in their proposed Supplemental Budget No. 2 for CY 2025 which was enacted by their Sangguniang Bayan through Appropriation Ordinance No. 2025-002 on March 10, 2025.

**WHEREAS**, the Sangguniang Panlalawigan, after final evaluation, finds the subject resolution in order, however, compliance with all the existing laws, rules and regulations shall be the responsibility of the Municipal Government of Laoac, Pangasinan;

**WHEREFORE**, in view of the foregoing, on motion of SP Member Napoleon C. Fontelera, Jr., duly seconded, it was—

**RESOLVED**, by the Sangguniang Panlalawigan in session assembled, to approve Resolution No. 2025-032 of the Sangguniang Bayan of Laoac, Pangasinan, entitled “Approving the Supplemental Annual Investment Plan (SAIP) No. 2 for Calendar Year 2025 of the Municipality of Laoac, Pangasinan amounting to One Million One Hundred Eighty-Three Thousand Pesos (P1,183,000.00)”;
