APPROVING RESOLUTION NO. 2025-090, S-2025 OF THE SANGGUNANG BAYAN OF SISON, PANGASINAN, ENTITLED "APPROVING THE 1ST SUPPLEMENTAL ANNUAL INVESTMENT PROGRAM-CY 2025 OF THE MUNICIPALITY OF SISON, PANGASINAN"

WHEREAS, the Sangguniang Bayan of Sison, Pangasinan submitted its Resolution No. 2025-090, S-2025 to the Sangguniang Panlalawigan for review and evaluation pursuant to Section 56 of the Republic Act No. 7160, otherwise known as the Local Government Code of 1991;

WHEREAS, the Committee on Laws and Ordinances of the Sangguniang Panlalawigan with the technical assistance of the Provincial Planning and Development Officer have conducted initial review and study on said Resolution with the following findings:

1. Subject resolution is in consonance with Sections 106, 109 and 114 of the Local Government Code (LGC) of 1991. The Municipal Development Council of Sison, Pangasinan has identified items in their Supplemental Annual Investment Program No. 1. This was endorsed to the Sangguniang Bayan for approval on March 14, 2025 by the Municipal Development Council through Resolution 01-2025;
2. The said SAIP covers fund augmentation for the Personal Services, MOOE and Capital Outlay of some municipal offices and the implementation of priority development projects and disaster risk reduction program/activities of the LGU; and

3. Funding support for the full implementation of the same in the amount of Php 38,892,158.30 is embodied in their Supplemental Budget No. 1 for CY 2025 which was enacted by their Sangguniang Bayan thru Appropriation Ordinance No. 01, Series of 2025 on March 24, 2025 and approved by the Local Chief Executive on March 28, 2025.


WHEREAS, the Sangguniang Panlalawigan, after final evaluation, finds the subject resolution in order, however, compliance with all the existing laws, rules and regulations shall be the responsibility of the Municipal Government of Sison, Pangasinan;

WHEREFORE, in view of the foregoing, on motion of SP Member Napoleon C. Fontelera, Jr., duly seconded, it was—

RESOLVED, by the Sangguniang Panlalawigan in session assembled, to approve Resolution No. 2025-090, S-2025 of the Sangguniang Bayan of Sison, Pangasinan, entitled “Approving the 1st Supplemental Annual Investment Program-CY 2025 of the Municipality of Sison, Pangasinan”;
