**RESOLUTION NO. 546-2025**

**DECLARING MUNICIPAL ORDINANCE NO. 2025-01 OF THE SANGGUNIANG BAYAN OF BALUNGAO, PANGASINAN, ENTITLED “AMENDING SECTION 5B.01 (7), ARTICLE B, CHAPTER V OF THE 2018 REVENUE CODE OF THE MUNICIPALITY OF BALUNGAO, PANGASINAN” AS WITHIN THE CONFERRED POWERS OF THE SANGGUNIAN TO ENACT**

**WHEREAS**, the Sangguniang Bayan of Balungao, Pangasinan submitted its Ordinance No. 2025-01 to the Sangguniang Panlalawigan for review and evaluation pursuant to Section 56 of Republic Act No. 7160, otherwise known as the Local Government Code of 1991;

**WHEREAS**, the Committee on Laws and Ordinances of the Sangguniang Panlalawigan with the technical assistance of the Provincial Legal Officer have conducted initial review and study on said ordinance and found out that the power of the sangguniang bayan to enact ordinances and approve resolutions carries with it the power to amend, revoke, modify, or repeal the same and was enacted in accordance with Section 447 (a) (3) (i) (vi) of Republic Act No. 7160;

**WHEREAS**, the subject ordinance shall take effect after compliance with the requirement of publication pursuant to Section 188 of R.A. No. 7160;

**WHEREFORE**, in view of the foregoing, on motion of SP Member Napoleon C. Fontelera, Jr., duly seconded, it was—

**RESOLVED**, by the Sangguniang Panlalawigan in session assembled, to declare Municipal Ordinance No. 2025-01 of the Sangguniang Bayan of Balungao, Pangasinan, entitled “Amending Section 5B.01 (7), Article B, Chapter V of the 2018 Revenue Code of the Municipality of Balungao, Pangasinan” as within the conferred powers of the Sangguniang Bayan to enact;
