RESOLUTION NO. 547-2025

DECLARING MUNICIPAL ORDINANCE NO. 2025-02 OF THE SANGGUNIANG BAYAN OF BALUNGAO, PANGASINAN, ENTITLED “NAMING OF APOLINARIO MABINI PARK, PROVIDING POLICIES AND GUIDELINES, APPROPRIATION OF FUNDS FOR ITS MAINTENANCE AND FOR OTHER PURPOSES AND IMPOSITION OF PENALTIES FOR VIOLATIONS THEREOF” AS WITHIN THE CONFERRED POWERS OF THE SANGGUNIAN TO ENACT

WHEREAS, the Sangguniang Bayan of Balungao, Pangasinan submitted its Ordinance No. 2025-02 to the Sangguniang Panlalawigan for review and evaluation pursuant to Section 56 of Republic Act No. 7160, otherwise known as the Local Government Code of 1991;

WHEREAS, the Committee on Laws and Ordinances of the Sangguniang Panlalawigan with the technical assistance of the Provincial Legal Officer and the Local Finance Committee of the Province have conducted initial review and study on said ordinance and found out that the same was enacted in accordance with Sections 13 (b) (1) (2) (3) (4) (5) (c) (60) (7) (8) (9) (d) (h) and 447 (a) (5) (v) of Republic Act No. 7160;

WHEREAS, it is now the incumbent on the part of the Local Chief Executive in coordination with the Municipal Local Finance Committee to provide an appropriation for the implementation of the subject ordinance to ensure the execution of said noble legislation;

WHEREFORE, in view of the foregoing, on motion of SP Member Napoleon C. Fontelera, Jr., duly seconded, it was—


