RESOLUTION NO. 549-2025

APPROVING RESOLUTION NO. 96, S-2025 OF THE SANGGUNANG BAYAN OF ASINGAN, PANGASINAN, ENTITLED "APPROVING THE MUNICIPAL DEVELOPMENT COUNCIL RESOLUTION NUMBER 1 WITH THE CY 2025 SUPPLEMENTAL ANNUAL INVESTMENT PROGRAM NUMBER 1 OF THE MUNICIPALITY OF ASINGAN, PANGASINAN"

WHEREAS, the Sangguniang Bayan of Asingan, Pangasinan submitted its Resolution No. 96, S-2025 to the Sangguniang Panlalawigan for review and evaluation pursuant to Section 56 of the Republic Act No. 7160, otherwise known as the Local Government Code of 1991;

WHEREAS, the Committee on Laws and Ordinances of the Sangguniang Panlalawigan with the technical assistance of the Provincial Planning and Development Officer have conducted initial review and study on said Resolution with the following findings:

1. Subject resolution is in consonance with Sections 106, 109 and 114 of the Local Government Code (LGC) of 1991. The Local Development Council of Asingan, Pangasinan had identified items in their Supplemental Annual Investment Program (SAIP) No. 1 for CY 2025. This was endorsed to the Sangguniang Bayan for approval on March 7, 2025 by the Municipal Development Council through Resolution No. 1, S-2025; and
2. The SAIP No. 1 with a total investment requirement amounting to P2,511,520.50 covers fund for the implementation of the development project "Purchase of lot for Housing Projects/Multi-Purpose Government Center".
