RESOLUTION NO. 551-2025

DECLARING MUNICIPAL ORDINANCE NO. 2024-16 OF THE SANGGUNIANG BAYAN OF AGNO, PANGASINAN, ENTITLED "AN ORDINANCE ENACTING THE TOURISM CODE OF THE MUNICIPALITY OF AGNO, PANGASINAN, CREATING AND STRENGTHENING THE AGNO MUNICIPAL TOURISM AND CULTURAL AFFAIRS OFFICE FOR THE DEVELOPMENT AND PROMOTION OF LOCAL ENVIRONMENT-FRIENDLY TOURISM INDUSTRY" AS WITHIN THE CONFERRED POWERS OF THE SANGGUNIAN TO ENACT

WHEREAS, the Sangguniang Bayan of Agno, Pangasinan submitted its Municipal Ordinance No. 2024-16 to the Sangguniang Panlalawigan for review and evaluation pursuant to Section 56 of Republic Act No. 7160, otherwise known as the Local Government Code of 1991;

WHEREAS, the Committee on Laws and Ordinances of the Sangguniang Panlalawigan with the technical assistance of the Provincial Legal Officer have conducted initial review and study on said municipal ordinance and found out that the same was enacted in accordance with Sections 16 (2)(vi), 447 (1)(iii) of Republic Act No. 7160, and Republic Act No. 9593, also known as "The Tourism Act of 2009";

WHEREAS, the subject ordinance shall take effect after compliance with the requirements of posting and publication pursuant to Sections 59 (c) and 511 (a) of R.A. No. 7160;
