RESOLUTION NO. 552-2025

DECLARING ORDINANCE NO. 2023-39 OF THE SANGGUNIANG PANLUNGSOD OF ALAMINOS, PANGASINAN, ENITLTED "AN ORDINANCE TRANSFERRING ELEVEN (11) POSITIONS FROM ONE OFFICE TO THE OTHER UNDER THE EXECUTIVE DEPARTMENT OF THE LOCAL GOVERNMENT UNIT OF THE CITY OF ALAMINOS, PANGASINAN" AS WITHIN THE CONFERRED POWERS OF THE SANGGUNIAN TO ENACT

WHEREAS, the Sangguniang Panlungsod of Alaminos, Pangasinan submitted its City Ordinance No. 2023-39 to the Sangguniang Panlalawigan for review and evaluation pursuant to Section 56 of Republic Act No. 7160, otherwise known as the Local Government Code of 1991;

WHEREAS, the Committee on Laws and Ordinances of the Sangguniang Panlalawigan with the technical assistance of the Local Finance Committee of the Province have conducted initial review and study on said ordinance and found out that the same was enacted in accordance with Republic Act No. 7160;

WHEREFORE, in view of the foregoing, on motion of SP Member Napoleon C. Fontelera, Jr., duly seconded, it was—

RESOLVED, by the Sangguniang Panlalawigan in session assembled, to declare City Ordinance No. 2023-39 of the Sangguniang Panlungsod of Alaminos, Pangasinan, entitled "An Ordinance transferring eleven (11) positions from one office to the other under the executive department of the Local Government Unit of the City of Alaminos, Pangasinan" as within the conferred powers of the Sangguniang Panlungsod to enact;
