DECLARING ORDINANCE NO. 2025-07 OF THE SANGGUNIANG PANLUNGSOD OF ALAMINOS, PANGASINAN, ENTITLED "AN ORDINANCE AMENDING PARAGRAPH I, SECTION 5 OF 2022-13 **ENTITLED "ORDINANCE** ORDINANCE NO. PRESCRIBING FEES FOR MEDICINES, SUPPLIES AND SERVICES PROVIDED TO PATIENTS AT THE ALAMINOS CITY DIALYSIS CLINIC, AMENDING FOR THIS PURPOSE SECTION 5 OF ORDINANCE NO. 2021-02 AND REPEALING ORDINANCE NO. 2022-07 ENACTED ON 27 JUNE 2022 OF THE CITY OF ALAMINOS, PANGASINAN" TO PRESCRIBE THE ADJUSTED RATE FOR HEMODIALYSIS TREATMENT BENEFIT PACKAGE PURSUANT TO PHILHEALTH CIRCULAR NO. 2024-0023" AS WITHIN THE **CONFERRED POWERS OF THE SANGGUNIAN TO ENACT**

WHEREAS, the Sangguniang Panlungsod of Alaminos, Pangasinan submitted its City Ordinance No. 2025-07 to the Sangguniang Panlalawigan for review and evaluation pursuant to Section 56 of Republic Act No. 7160, otherwise known as the Local Government Code of 1991;

WHEREAS, the Committee on Laws and Ordinances of the Sangguniang Panlalawigan with the technical assistance of the Provincial Legal Officer have conducted initial review and study on said ordinance and found out that the same was enacted in accordance with Sections 129, 132 and 458 (a)(3)(i) of Republic Act No. 7160;

WHEREAS, the subject ordinance shall take effect after compliance with the requirement of publication pursuant to Section 511 (a) of R.A. No. 7160;
