RESOLUTION NO. 554-2025

DECLARING ORDINANCE NO. 2025-08 OF THE SANGGUNIANG PANLUNGSOD OF ALAMINOS, PANGASINAN, ENTITLED “AN ORDINANCE REVISING THE CHILDREN’S CODE OF THE CITY OF ALAMINOS, PANGASINAN” AS WITHIN THE CONFERRED POWERS OF THE SANGGUNIANG PANLUNGSOD TO ENACT

WHEREAS, the Sangguniang Panlungsod of Alaminos, Pangasinan submitted its City Ordinance No. 2025-08 to the Sangguniang Panlalawigan for review and evaluation pursuant to Section 56 of Republic Act No. 7160, otherwise known as the Local Government Code of 1991;

WHEREAS, the Committee on Laws and Ordinances of the Sangguniang Panlalawigan with the technical assistance of the Provincial Legal Officer have conducted initial review and study on said municipal ordinance and found out that the same was enacted in accordance with PD 603 or “The Child and Youth Welfare Code, United Nations Convention on the Rights of the Child (CRC), Republic Act No. 7610 of 1992 (Special Protection of Children Against Child Abuse, Exploitation, and Discrimination Act), otherwise known as the “Child Protection Law”, and Section 17 (b) (2) (iii) (iv) (5) (xiv) of Republic Act No. 7160;

WHEREAS, the subject ordinance shall take effect after compliance with the requirement of publication pursuant to Section 511 (a) of R.A. No. 7160;

WHEREFORE, in view of the foregoing, on motion of SP Member Napoleon C. Fontelera, Jr., duly seconded, it was—
