DECLARING ORDINANCE 095, S-2025 OF THE NO. SANGGUNIANG BAYAN OF LABRADOR, PANGASINAN, "AN ORDINANCE PRESCRIBING SAFETY ENTITLED **GUIDELINES IN THE OPERATION OF COASTAL AND BEACH RESORTS, MOUNTAIN RESORTS, RIVER BATHS, IRRIGATION** SYSTEMS, WATERFALLS AND SIMILAR ESTABLISHMENTS AND PLACES AND PROVIDING PENALTIES THEREOF" AS WITIHIN THE CONFERRED POWERS OF THE SANGGUNIAN TO **ENACT**

WHEREAS, the Sangguniang Bayan of Labrador, Pangasinan submitted its Municipal Ordinance No. 095, S-2025 to the Sangguniang Panlalawigan for review and evaluation pursuant to Section 56 of Republic Act No. 7160, otherwise known as the Local Government Code of 1991;

WHEREAS, the Committee on Laws and Ordinances of the Sangguniang Panlalawigan with the technical assistance of the Provincial Legal Officer have conducted initial review and study on said municipal ordinance and found out that the same was enacted in accordance with Sections 16, 447 (a)(1)(iii)(6) of Republic Act No. 7160;

WHEREAS, the subject ordinance shall take effect after compliance with the requirement of publication pursuant to Section 511 (a) of R.A. No. 7160;
