### RESOLUTION NO. 557-2025

**DECLARING MUNICIPAL ORDINANCE NO. 2, S-2025 OF THE SANGGUNANG BAYAN OF BINMALEY, PANGASINAN, ENTITLED “AN ORDINANCE RENAMING THE BINMALEY EVACUATION CENTER TO BINMALEY MULTI-PURPOSE AND EVACUATION CENTER, AND PRESCRIBING THE RATES/FEES/CHARGES FOR ITS USE THEREOF” AS WITHIN THE CONFERRED POWERS OF THE SANGGUNIAN TO ENACT**

**WHEREAS**, the Sangguniang Bayan of Binmaley, Pangasinan submitted its Municipal Ordinance No. 2, S2025 to the Sangguniang Panlalawigan for review and evaluation pursuant to Section 56 of Republic Act No. 7160, otherwise known as the Local Government Code of 1991;

**WHEREAS**, the Committee on Laws and Ordinances of the Sangguniang Panlalawigan with the technical assistance of the Provincial Legal Officer have conducted initial review and study on said municipal ordinance and found out that the same was enacted in accordance with Sections 13 (c)(1)(2)(3)(4)(5)(d)(h), 129, 132, 153, 154, 458 (a)(3)(i) of Republic Act No. 7160;

**WHEREAS**, the subject ordinance shall take effect after compliance with the requirement of publication pursuant to Section 511 (a) of R.A. No. 7160;

**WHEREFORE**, in view of the foregoing, on motion of SP Member Napoleon C. Fontelera, Jr., duly seconded, it was—

**RESOLVED**, by the Sangguniang Panlalawigan in session assembled, to declare Municipal Ordinance No. 2, S-2025 of the Sangguniang Bayan of Binmaley, Pangasinan, entitled “An Ordinance renaming the Binmaley Evacuation Center to Binmaley Multi-Purpose and Evacuation Center, and prescribing the rates/fees/charges for its use thereof” as within the conferred powers of the Sangguniang Bayan to enact;
