**APPROVING RESOLUTION NO. 32-2025 OF THE SANGGUNIANG  
BAYAN OF URBIZTONDO, PANGASINAN, ENTITLED  
“APPROVING THE REVISED ANNUAL INVESTMENT PROGRAM  
(AIP) FOR FISCAL YEAR 2025 OF THE MUNICIPALITY OF  
URBIZTONDO, PANGASINAN”**

**WHEREAS**, the Sangguniang Bayan of Urbiztondo, Pangasinan submitted its Resolution No. 32-2025 to the Sangguniang Panlalawigan for review and evaluation pursuant to Section 56 of the Republic Act No. 7160, otherwise known as the Local Government Code of 1991;

**WHEREAS**, the Committee on Laws and Ordinances of the Sangguniang Panlalawigan with the technical assistance of the Provincial Planning and Development Coordinator have conducted initial review and study on said Resolution with the following findings:

1. Subject resolution is in consonance to Sections 106, 109 and 114 of the Local Government Code of 1991. The Municipal Development Council of Urbiztondo, Pangasinan has identified items in their Revised Annual Investment Program for FY 2025. This was endorsed to the Sangguniang Bayan on March 1, 2025 through MDC Resolution No. 3, Series 2025;
2. The AIP of LGU Urbiztondo for CY 2025 was revised to integrate the proposed disaster risk reduction and management programs/projects/activities to be funded from the Unexpended Balances of the LGU's LDRRM Fund, CY 2024 amounting to Php3,782,315.98, which was emanated from the MDRRM Council through Resolution No. 02, Series of 2025 dated March 1, 2025. This is in pursuance to Section 6.5 of the NDRRM-DBM-DILG Joint Memorandum Circular No. 2013-01 dated March 25, 2013, which states:

“The unexpended balances of the LDRRMF may be released and utilized for new expenditure items upon submission of a revised AIP as approved by the Local Sanggunian and Local Chief Executive (LCE) upon recommendation of the LDRRMC in accordance with the approved LDRRMP.”

3. The DRRM projects proposed to be funded from the Unexpended Balances of LDRRM Fund are based on Joint Memorandum Circular No. 2013-1 of the NDRRMC, DBM & DILG dated March 25, 2013 (Allocation and Utilization of the Local Disaster Risk Reduction and Management Fund).


**WHEREAS**, the Sangguniang Panlalawigan, after final evaluation, finds the subject resolution in order, however, compliance with all the existing laws, rules and regulations shall be the responsibility of the Municipal Government of Urbiztondo, Pangasinan;

**WHEREFORE**, in view of the foregoing, on motion of SP Member Napoleon C. Fontelera, Jr., duly seconded, it was—

**RESOLVED**, by the Sangguniang Panlalawigan in session assembled, to approve Resolution No. 32-2025 of the Sangguniang Bayan of Urbiztondo, Pangasinan, entitled “Approving the Revised Annual Investment Program (AIP) for Fiscal Year 2025 of the Municipality of Urbiztondo, Pangasinan”;
