RESOLUTION NO. 565-2025

DECLARING ORDINANCE NO. 24-24 OF THE SANGGUNIANG PANLUNGSOD OF SAN CARLOS, PANGASINAN, ENTITLED “AN ORDINANCE ADOPTING SECTION 30, ARTICLE V, OF REPUBLIC ACT NO. 12001, OTHERWISE KNOWN AS THE “REAL PROPERTY VALUATION AND ASSESSMENT REFORM ACT”, AUTHORIZING THE GRANT OF TAX AMNESTY ON REAL PROPERTY AND SPECIAL LEVIES ON REAL PROPERTY WITHIN THE TERRITORIAL JURISDICTION OF THE CITY OF SAN CARLOS, (PANGASINAN), FOR A PERIOD OF TWO (2) YEARS UPON THE EFFECTIVITY OF THE ACT” AS WITHIN THE CONFERRED POWERS OF THE SANGGUNIAN TO ENACT

WHEREAS, the Sangguniang Panlungsod of San Carlos, Pangasinan submitted its Ordinance No. 24-24 to the Sangguniang Panlalawigan for review and evaluation pursuant to Section 56 of Republic Act No. 7160, otherwise known as the Local Government Code of 1991;

WHEREAS, the Committee on Laws and Ordinances of the Sangguniang Panlalawigan with the technical assistance of the Provincial Legal Officer have conducted initial review and study on said ordinance and found out that the same was enacted in accordance with Sections 129, 132 & 192 of R.A. No. 7160; and Republic Act No. 12001, otherwise known as the “Real Property Valuation and Assessment Reform Act;

WHEREAS, the subject ordinance shall take effect after compliance with the requirements of posting, public hearing and publication pursuant to Sections 59 (a), 187 & 188 of R.A. No. 7160;

WHEREFORE, in view of the foregoing, on motion of SP Member Napoleon C. Fontelera, Jr., duly seconded, it was—
