RESOLUTION NO. 566-2025

DECLARING ORDINANCE NO. 24-25 OF THE SANGGUNIANG PANLUNGSOD OF SAN CARLOS, PANGASINAN, ENTITLED "AN ORDINANCE ADOPTING THE PROVINCIAL ORDINANCE NO. 325-2024, ENTITLED: "AN ORDINANCE REQUIRING INCREASED NIGHTTIME VISIBILITY AMONG MOTORCYCLE, BICYCLE, E-TRIKE RIDERS THROUGH THE USE OF HIGH-VISIBILITY REFLECTIVE VESTS OF LUMINOUSLY-COLORED GARMENTS FOR ALL MOTORCYCLE, AND TRICYCLE RIDERS AND **LUMINOUS-COLORED** REFLECTIVE **GARMENTS** VEST. AND/OR HIGH-VISIBILITY LIGHTS FOR BICYCLE AND E-BIKE AND E-TRIKE RIDERS WHILE TRAVELING ALONG THE THOROUGHFARES OF THE PROVINCE OF PANGASINAN FROM 6 P.M. TO 6 A.M. AND PROVIDING PENALTIES THEREOF" IN THE CITY OF SAN CARLOS, PANGASINAN" AS WITHIN THE CONFERRED POWERS OF THE SANGGUNIAN TO ENACT

WHEREAS, the Sangguniang Panlungsod of San Carlos, Pangasinan submitted its Ordinance No. 24-25 to the Sangguniang Panlalawigan for review and evaluation pursuant to Section 56 of Republic Act No. 7160, otherwise known as the Local Government Code of 1991;

WHEREAS, the Committee on Laws and Ordinances of the Sangguniang Panlalawigan with the technical assistance of the Provincial Legal Officer have conducted initial review and study on said ordinance and found out that the same was enacted in accordance with Section 16 of R.A. No. 7160;

WHEREAS, the subject ordinance shall take effect after compliance with the requirements of posting and publication pursuant to Sections 59 (c) and 511 (a) of R.A. No. 7160;

WHEREFORE, in view of the foregoing, on motion of SP Member Napoleon C. Fontelera, Jr., duly seconded, it was—

RESOLVED, by the Sangguniang Panlalawigan in session assembled, to declare Ordinance No. 24-25 of the Sangguniang Panlungsod of San Carlos, Pangasinan, entitled "An Ordinance adopting the Provincial Ordinance No. 325-2024, entitled: "An Ordinance requiring increased nighttime visibility among motorcycle, bicycle, e-trike riders through the use of high-visibility reflective vests of luminously-colored garments for all motorcycle, and tricycle riders and reflective vest, luminous-colored garments and/or high-visibility lights for bicycle and e-bike and e-trike riders while traveling along the thoroughfares of the Province of Pangasinan from 6 p.m. to 6 a.m. and providing penalties thereof" in the City of San Carlos, Pangasinan" as within the conferred powers of the Sangguniang Panlungsod to enact;
